## Summary of key findings for parents

## This provision is outstanding

- The childminder has excellent self-evaluation skills and a drive to improve. She seeks feedback from parents and children to continuously improve the service she provides.
- The childminder is highly dedicated to her role and focuses on meeting the needs of every child in her care. She has an excellent understanding of how children learn and, with her support and outstanding teaching, children make rapid progress.
- Children are very confident and show very high levels of independence, and they freely explore the highly stimulating home environment. They are all highly motivated to learn, become very involved in activities and develop skills for their next stage of learning.
- The childminder knows the children extremely well. She makes regular, highly accurate assessments of children's progress, monitoring and tracking their learning and development. This helps the childminder to provide exceptionally interesting and challenging activities and close any gaps in the children's learning.
- Partnerships with parents are exceptional. Parents' comments are extremely positive and they enjoy the opportunity to see their children's photographs and interact with the other parents.
- Children's safety is of the highest priority. The childminder completes thorough risk assessments and encourages the children to be aware of their own safety.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

broaden on the already excellent practice to further develop children's understanding of nature and healthy eating for those who learn best outside.

- The inspector observed children participating in activities and interacting with the childminder.
- The inspector spoke with the childminder and children at appropriate times throughout the inspection.
- The inspector reviewed the children's assessment records and a selection of policies and procedures, including safeguarding.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The childminder is a committed professional who relentlessly pursues excellence to ensure outstanding outcomes for the children and parents. For example, she has completed a further early years qualification since her previous inspection. She regularly attends training, evaluating the workshops for new ideas to use in her setting and the impact these will have on the children. Safeguarding is effective. The highly knowledgeable childminder has an exemplary understanding of the procedures to follow if she has concerns about a child in her care. She exchanges extensive information with parents in a variety of ways including, for example, a closed network site where parents can see their children's learning and talk to each other. This helps to ensure a highly consistent approach to the children's care and development. Following her last inspection, the childminder developed her assessment and tracking of the children's learning, allowing her to develop more detailed planning and close any gaps in children's learning more rapidly.

## Quality of teaching, learning and assessment is outstanding

Children thoroughly enjoy their learning and are enthusiastic to join in with the rich, varied and imaginative learning experiences. The quality of teaching is excellent. The childminder extends their play very successfully, asks questions, develops the older children's thinking skills and introduces new vocabulary for the younger ones. She very successfully promotes children's confidence, boosts their self-esteem and early reading skills. For example, children proudly show their own named stone as they find it in the oats. The childminder has an excellent partnership with the nursery her children attend and they regularly exchange information and discuss any concerns. This helps to ensure an outstanding continuity of care and joint learning objectives.

#### Personal development, behaviour and welfare are outstanding

The childminder provides a very warm and welcoming environment where children form excellent relationships with her and the other children. Children learn excellent hygiene routines and the childminder promotes healthy lifestyles very well. For example, during snack time and pretend games, she talks to the children about healthy foods, although there are slightly fewer opportunities for these discussions in the outdoor area. Children have outstanding opportunities to develop physical and social skills, for example, as they play on the equipment in the garden and attend toddler groups. The childminder is an excellent role model. She encourages children of all ages to share and take turns and display excellent manners. Children learn how to be kind to each other and play together.

#### **Outcomes for children are outstanding**

Children are highly motivated learners who make excellent progress across all areas of their learning. They are exceptionally well prepared for their move on to school.
