## Summary of key findings for parents

## This provision is outstanding

- The quality of the childminder's teaching and her interactions with all children are outstanding. The childminder has extremely high expectations of all children and a thorough understanding of how they learn.
- The highly experienced childminder has very high expectations of all children. Her commentary and questions throughout activities are sharply focused and purposeful.
- Children have developed very strong attachments to the childminder and are extremely confident and self-assured. Children receive high levels of individual attention, excellent guidance and support from the childminder. Children are prepared exceptionally well for their move on to school.
- The childminder is very caring and highly responsive to the individual needs of all children. She interacts extremely well with children. As a result, they make swift progress because there is a superb balance of child-initiated and adult-led activities that are supported by high-quality teaching.
- The childminder has an excellent understanding of all legal and statutory requirements and meets these in full. Highly effective policies and procedures, which are shared with parents, underpin her outstanding practice.
- The childminder and her co-childminder have a superb working relationship. Their continuous evaluation of the provision means that they are always looking at ways to improve outcomes for children.

# **Inspection findings**

### Effectiveness of the leadership and management is outstanding

The childminder is enthusiastic and deeply committed to her role. She is extremely reflective and continually seeks ways to improve her practice even further. The arrangements for safeguarding are effective. The childminder has an excellent understanding of how to keep children safe and the procedures to follow should she have any concerns about a child in her care. Children's learning and development requirements are exceptionally well met. The childminder provides children with rich experiences across all areas of learning. Parents are provided with ideas and guidance to continue their children's learning at home. The childminder is keen to consider other innovative ways to continue to offer this support.

### Quality of teaching, learning and assessment is outstanding

Through skilful teaching, exploiting opportunities during routines and high-quality interactions, the childminder introduces new vocabulary and written words. Children's communication and language are promoted exceptionally well. The childminder is highly skilled in using conversational skills to promote children's thinking and listening, which encourages children to express themselves. For example, children become absorbed in sprinkling glitter and making patterns in fine sand. This helps them to refine their physical skills and foster their imagination. Children thrive and are stimulated to learn in this very welcoming, extremely child-focused environment. The childminder has a superb understanding of the different ways children learn. Children eagerly choose what they would like to do from the excellent range of resources. The childminder plans activities exceptionally well, providing a rich, child-friendly environment which fosters children's curiosity.

#### Personal development, behaviour and welfare are outstanding

During initial visits there is a strong focus on finding out information about home routines, interests and existing skills and capabilities. This is used extremely well by the childminder to help children settle quickly when they first start to attend. Highly effective partnerships between the childminder, parents and other providers ensure children's individual needs are known and exceptionally well met. Parents' comments are highly positive of the experiences provided for their children. Children behave well and display high levels of cooperation and respect for each other. The childminder is an excellent role model and consistently reminds them of the rules and boundaries. Children demonstrate self-confidence and pride in their achievements.

#### **Outcomes for children are outstanding**

Children flourish and make excellent progress, given their starting points, including those who receive funded early education. The childminder takes full account of children's preferred learning styles, interests and fascinations. The wealth of skills that children gain ensures that they are well prepared for school.
