## Summary of key findings for parents

## This provision is outstanding

- The childminder is dedicated to her role and has a strong drive to continually provide the best possible care and education. She constantly reviews the quality of her provision to help her to provide outstanding care and education.
- Children are extremely happy and settled in this homely environment. They are provided with warmth and affection and show a strong sense of belonging, which helps to promote their emotional well-being.
- The quality of teaching is consistently high. The childminder has an excellent understanding of how young children learn. All children are exceptionally well motivated and very eager to join in with activities.
- Children's enthusiasm for learning is boosted by the childminder's natural ability to provide a rich, varied and imaginative range of experiences. Children are rapidly gaining the skills that they need in preparation for school.
- The childminder has developed extremely strong links with the local school and settings that children move on to. She continually exchanges detailed information about children so that continuity of care and learning is always promoted to the highest level.
- Children have opportunities to explore and play in an exceptionally well-resourced outdoor environment. They move around and are active, which helps to foster their physical development.
- The childminder is committed to meeting each child's individual medical and care needs. She meticulously plans and prepares menus that take into account all dietary requirements to help to ensure children's good health.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

 continue to extend and challenge older and more-able children's understanding of technology and materials.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The childminder has a secure understanding of the requirements of the Early Years Foundation Stage. She uses her wealth of experience and knowledge to provide outstanding care and education for the children who attend. The arrangements for safeguarding are effective. She fully understands her responsibility to promote children's welfare and safety. The childminder keeps her training up to date. She continually refreshes her knowledge and seeks further information to strengthen her professional practice. The childminder is an active member of a local network of childminders. She uses every opportunity to reflect on the quality of her own provision with other professionals. Her commitment and drive are evident and children clearly benefit from spending time in the excellent environment.

## Quality of teaching, learning and assessment is outstanding

The childminder's enthusiasm and commitment to teaching children help make sure that they readily take part in all activities. Children are excited to explore and investigate the thoughtfully planned experiences that she offers. When they return from nursery they are immediately curious about what the childminder has prepared. They excitedly explore a range of materials in the garden. Children show that they are beginning to understand why things happen and how things work as they use magnets to find hidden treasure. They ask questions and express their own opinions about what they observe. Older and more-able children think critically about what they are doing. The childminder identifies that there are opportunities for her to challenge children even further to build on these rapidly developing skills. She is quick to recognise when some children lose interest and she maintains their concentration skills when she introduces favourite dinosaur toys. The childminder observes children's play and assesses their development. She works out the right level of support needed to enable them to make excellent progress. The childminder has strong relationships with parents and is highly regarded by them. She continually shares detailed information about their children's time with her.

## Personal development, behaviour and welfare are outstanding

Children flourish with the childminder. Her child-centred approach helps to ensure their emotional well-being. She strives to promote each child's cultural identity. Children's similarities and differences are celebrated. They gain an excellent understanding of themselves and the world around them. Children are extremely self-assured and are well mannered. The childminder has high expectations of behaviour and she makes sure young children quickly learn social skills that help to prepare them in readiness for school. Children's communication and language skills are superb. They have continued opportunities to engage in meaningful conversations about what they are doing.

#### **Outcomes for children are outstanding**

Children show that they become very confident and capable learners who are excited and motivated to learn. All children make swift progress from their starting points because of the first-rate learning opportunities that they are provided with. They are exceptionally well prepared in readiness for the next stage in their learning, including school.
