# Summary of key findings for parents

# This provision is good

- The childminder skilfully supports children to feel secure and confident so that they become curious and keen learners.
- The childminder uses effective and consistent teaching strategies overall, which supports children to make good progress.
- The childminder uses assessment procedures successfully to identify children's starting points and any gaps in their learning. She supports children well to catch up where necessary.
- The childminder reflects on her practice thoughtfully and accurately to drive improvement and maintain good outcomes for children.
- The childminder has a clear awareness of safeguarding procedures. She provides a safe and welcoming environment and supervises children closely to promote their welfare.

## It is not yet outstanding because:

- Children do not always have the opportunity to select from a wide range of activities and resources to extend their awareness of the world around them.
- Children sometimes miss out on opportunities to explore their own ideas and think of solutions.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- extend opportunities for children to have a wider range of activities and more choice in how they explore resources across the learning environment, to develop their awareness of the world around them
- extend teaching strategies for encouraging children to explore their own ideas and think of solutions.

- The inspector observed activities indoors.
- The inspector completed a joint observation with the childminder.
- The inspector took account of the childminder's self-evaluation form and written comments from parents.
- The inspector looked at children's development records.
- The inspector talked to the childminder about her practice at appropriate points throughout the inspection.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

The childminder has a good understanding of her responsibilities. Safeguarding is effective. The childminder keeps up to date with new legislation and attends training routinely to develop her knowledge in this area. Since the last inspection, the childminder has improved several aspects of practice. For example, she has extended resources and activities to help children learn more about people from different backgrounds. The childminder receives positive feedback from parents, who are clearly happy with the service she provides.

## Quality of teaching, learning and assessment is good

The childminder supports children's learning successfully overall. Children engage well in activities as the childminder plays alongside them, demonstrating how things work, making suggestions and providing a narrative. Children, including those who are learning English as an additional language, develop good communication skills. They acquire new vocabulary quickly and are able to express themselves confidently. The childminder works well in partnership with others. She engages parents well in their children's learning through daily discussions and written information. The childminder works closely with parents and staff in other settings that children attend, such as agreeing consistent strategies for potty training and behavioural expectations.

### Personal development, behaviour and welfare are good

Children develop respect and understanding towards others. For example, they find out about Braille and different cultural festivals. The childminder is a positive role model and encourages children to manage their own feelings effectively. Children remain safe and comfortable in her care. They enjoy healthy snacks and daily opportunities for outdoor play, which promotes their health and well-being successfully. Children learn to challenge their skills while staying safe, such as learning about safety procedures while using largescale equipment at the park.

#### Outcomes for children are good

All children, including those who are learning English as an additional language, make good progress from their starting points. They become confident and independent learners under the childminder's close guidance, which prepares them well for their next stages of learning and for school. Where gaps in learning are apparent, children catch up quickly as the childminder provides specific and well-considered support.
