Summary of key findings for parents

The provision meets requirements

- The childminder has appropriately risk assessed the areas that are to be used by children. She effectively highlights any hazards in the setting and takes steps to keep children safe.
- The childminder plans for children to have daily opportunities to play outdoors, through trips to local outdoor green spaces. Plans are underway to make the garden into an area suitable for use by children.
- The highly-qualified childminder has an understanding of how children learn. She knows how to plan interesting activities to support children's learning. The childminder knows how she will teach children and how to assess their development.
- The childminder demonstrates an ability to ensure that all children, including disabled children and those with special educational needs, are supported effectively. She has a wealth of experience in supporting children with many complex needs.
- The childminder knows which records she must keep and how to store them securely. She has clear plans to be well organised with her record keeping. Essential training, including first aid and safeguarding is completed appropriately. Relevant insurances are kept up to date.
- The childminder knows what to do if she has concerns that a child is being abused. She knows how to promote children's safety and well-being appropriately.
- The childminder uses a variety of techniques to keep her practice up to date. She has attended a wealth of training courses to deepen her knowledge, including courses to help her to meet the needs of disabled children and those with special educational needs. She also ensures that her property is accessible for wheelchair users.
- The childminder is highly reflective and has appropriate skills for reviewing and monitoring her own practice to ensure that she can help children to develop well from their starting points.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
