## Summary of key findings for parents

### This provision is good

- Staff are well qualified and have a good understanding of how children learn. They use their knowledge to plan activities and experiences that promote children's development across the areas of learning.
- Staff are highly skilled in helping children form secure emotional attachments. Sensitive settling-in arrangements ensure that children feel confident and are eager to become involved in activities. Staff take time to get to know families and their children well so they can support them to feel comfortable and happy using the nursery.
- The manager completes an accurate self-evaluation and regularly reviews the provision. She includes the views of those who use the nursery in her evaluations and acts on advice to drive continuous improvement.
- Children are well prepared for their future and starting school. They develop good self-help skills, confidence and independence because staff patiently encourage them to do things for themselves.
- Children enjoy learning in this well-planned and welcoming environment. They access a wide range of resources which helps them to develop their skills.

### It is not yet outstanding because:

- Staff do not plan highly effective activities for older children to ensure they consistently engaged and challenged in their learning.

## What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

- plan activities more precisely for older children that highly engage, enthuse and motivate them in making the best possible progress.

### Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors, and assessed the impact this has on children's learning.
- The inspector completed a joint observation with the nursery manager.
- The inspector held a meeting with the nursery manager and provider. She looked at relevant documentation, such as the nursery's self-evaluation and evidence of the suitability of staff working in the nursery.
- The inspector spoke to a small selection of parents during the inspection and took account of their views.

## Inspection findings

### Effectiveness of the leadership and management is good

Arrangements for safeguarding are effective. All staff have a good understanding of their responsibilities. They know what to do if they have a concern about a child in their care. Since the last inspection, managers provide good supervision for staff and have used training opportunities to improve the level of staff's knowledge. As a result, children's learning has continued to improve. Managers and staff have worked with a speech and language therapist to develop their expertise in language development. This has helped all children, including those eligible for additional funding. This is beginning to have a positive impact on children's progress. Managers effectively monitor the provision, including children's progress. Action plans for further improvement identify what needs to be developed. This means that gaps in children's learning are identified and action is taken to close gaps quickly.

### Quality of teaching, learning and assessment is good

Staff have a good understanding of how young children learn and develop. They complete regular observations and assessments of children which help them plan for children's learning. Staff plan the environment well so that each child can access a range of appropriate resources that they enjoy. Parents have access to children's learning files and receive regular updates about their child's progress. The manager organises settling-in sessions for families to attend. This helps to establish strong relationships with the parents. These sessions enable staff to gather information about children's development. Staff are also able to support parents to guide children's learning at home. Staff provide good opportunities for children to develop their early literacy and writing skills. For example, children practice writing their name on the cards they make to take home. This helps to equip children with key skills needed for their future learning. A regular exchange of information with parents provides a consistent approach to children's learning, both at the nursery and at home.

### Personal development, behaviour and welfare are good

Staff teach children how to keep themselves safe and healthy. Children have plenty of opportunities to use the outdoor area, which helps them develop their physical skills. They use wheeled toys and learn to use a variety of tools as they play in the mud kitchen. Children behave well, learn to respect each other and consider the needs of others as they play. Staff skilfully provide emotional support to children and babies as they settle. Children respond well to staff's caring and sensitive approach to meeting their emotional and care needs. This means that children develop confidence, are secure in the nursery and ready to learn.

### Outcomes for children are good

Children make good progress, including those who receive funded early education, from their starting points. They are confident and are gaining the skills they will need to be ready for school. Children gain in independence as they readily help with small tasks, such as helping to keep the play space tidy and dealing with their personal needs.

Oceans Day Nursery Ltd was registered in 2009. The nursery employs 23 members of childcare staff. Of these, 18 hold appropriate early years qualifications at level 3. The nursery opens from Monday to Friday all year round closing for one week at Christmas and for bank holidays. Sessions are from 7.15am until 6.15pm. The nursery provides funded early education for two-, three- and four-year-old children.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
