# **Summary of key findings for parents**

#### This provision requires improvement. It is not yet good because:

- The manager failed to notify Ofsted of a significant event. This also breaches a requirement of the Childcare Register.
- The quality of teaching is variable. Staff interactions with children do not always motivate them to engage fully in activities or consistently challenge their learning.
- Staff do not plan sufficiently for those children who learn best in the outdoor learning environment.
- Staff do not always provide a good range of opportunities for children to learn about cultural differences and the wider world.
- Self-evaluation is not effective in identifying key areas for development, to help make effective improvements that promote children's outcomes.

#### It has the following strengths

- Parents speak positively about the nursery and feel their children are safe and happy.
- Staff form positive relationships with children and encourage their independence skills well.
- Staff promote children's mathematical skills; for example, they help children develop an understanding of colours, shapes and numbers.

# **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

The manager failed to notify Ofsted about a significant event, which is a requirement of registration. She did not inform Ofsted about an allegation against a member of staff. There was no significant impact on children's safety because the manager followed safeguarding procedures. Safeguarding is effective. Staff receive suitable child protection training and understand the procedures to follow should they have any concerns regarding children's welfare. Self-evaluation is not fully effective. The manager identified some areas for development. However, she has not focused on supporting and training staff to improve practices that extend children's outcomes. The manager implements appropriate recruitment and vetting procedures to ensure staff are suitable. Detailed risk assessments contribute to keeping children safe when on outings or on the premises.

#### Quality of teaching, learning and assessment requires improvement

Staff complete regular observations and assessments of children's skills and interests. They share information with parents to keep them involved in their children's progress. However, the quality of teaching is variable. The manager and staff do not effectively review children's progress to ensure they make the best possible progress. For example, activities are set out for children; however, staff do not always focus on what children are expected to gain from these. This results in some missed opportunities to extend and challenge children's individual learning. Staff support children's communication and language skills; for example, they talk to children as they play and encourage conversations. Children have many opportunities to be independent. They behave well and develop sound social skills. Overall, children gain the necessary skills to support the next stage in their learning.

#### Personal development, behaviour and welfare require improvement

Children are happy and confidently explore their surroundings. Staff are good role models, such as helping children learn the value of good manners and sharing. Staff promote children's understanding of healthy lifestyles well. For example, they provide nutritious meals and snacks, talk to children about healthy foods and encourage children to serve themselves. Children have use of the garden during the day. However, staff do not always make the best use of all learning environments, for example, to challenge and encourage those children who prefer to learn outside. Children begin to learn about their community. However, staff do not always provide children with a range of opportunities to develop their awareness of other people in the wider world.

#### **Outcomes for children require improvement**

Children enjoy their time at the nursery and make some steady progress in their development. Overall, the older children develop skills they need to start school.
