- The childminder's home is warm and welcoming. She understands the importance of ensuring the environment is safe, clean and risk free. Resources provide variety and challenge.
- The childminder knows how to promote children's good health and has arrangements to provide daily opportunities for fresh air and physical exercise.
- The childminder understands how to safeguard children and promote their safety and welfare. She understands the signs that would cause her concern and knows how to report any concerns that may arise. The childminder maintains an appropriate range of policies and procedures to underpin her practices, which she shares with parents.
- The childminder understands how to ensure that children develop positive values that enable them to behave well and respect others.
- The childminder understands the importance of continuous development and effectively evaluates her practice to identify areas for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
