# Summary of key findings for parents

#### This provision is inadequate

- The childminder has failed to notify Ofsted of changes to household members. Therefore, not all of the adults living in the house have had appropriate checks to ensure their suitability and to promote children's safety.
- The childminder does not have an up-to-date knowledge of safeguarding issues. Therefore, she is not fully confident in identifying concerns or describing how she will deal with them.
- The childminder has not taken appropriate action with regards to all aspects of the protection of information to ensure children's safety.
- Teaching is poor. The childminder does not plan for children's individual stage of development. There is insufficient challenge for older and more-able children. Furthermore, she does not provide appropriate support for all areas of learning.
- The childminder over directs children's play. She continually interrupts children and tells them what to do and how to do it. She does not give children sufficient opportunities to play by themselves or together without adult interaction.

#### It has the following strengths

- The childminder maintains a clean environment and effectively manages nappy changing to minimise the risk of cross-infection.
- The childminder supports children as they start at her setting. She discusses children's needs with parents and carers. She also makes suggestions about changes to children's attendance, so that they settle more quickly.

#### **Inspection activities**

- The inspector observed the quality of teaching during activities indoors and assessed the impact this has on children's learning.
- The inspector discussed the planning of activities with the childminder.
- The inspector checked evidence of the suitability of adults living on the premises.
- The inspector looked at relevant documentation, such as the childminder's selfevaluation and evidence of training.
- The inspector spoke to a small selection of parents and carers during the inspection and took account of their views.

#### Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are ineffective. The childminder has not notified Ofsted that another adult has moved into the household. The childminder has not kept herself up to date with changes to safeguarding practice. She does not have a suitable awareness of current issues to ensure children are safeguarded. The childminder does have a suitable understanding of the different types of abuse. The childminder is aware of the requirements for the protection of information. However, she has failed to take appropriate action with regards to the use of electronic information. The childminder has attended training in observation, assessment and planning since her last inspection. However, she does not use this knowledge to help children to move forward in their learning.

#### Quality of teaching, learning and assessment is inadequate

The quality of teaching is poor. The childminder does not provide appropriate support for children's individual stage of development. Furthermore, she overly focuses on some areas of learning to the detriment of others. When children are indoors, the childminder does not encourage them to move around or engage in activities that promote their physical development. Instead, children sit on mats and younger children rarely make any attempts to move or stand. As the children sit and explore the toys and resources, the childminder constantly takes over. A younger child is enjoying filling a container with items but the childminder keeps emptying it. The child becomes frustrated and disengages from the activity. The childminder continually instructs children what to do with the toys until they comply. The childminder repeatedly asks older children struggle to engage in play for any length of time. Although they spend a large proportion of time in the same area of the lounge, they rarely interact with others. They often sit and watch or flit from one thing to another.

#### Personal development, behaviour and welfare are inadequate

Children's welfare is compromised because the childminder has not made sure that all of the safeguarding requirements are met. The childminder has very few toys that provide sufficient challenge for more-able children. However, children behave well, in spite of the poor-quality interactions and they rarely fall out. If children have an occasional squabble over toys, the childminder reminds them to share. The childminder promotes healthy eating through the provision of freshly prepared meals and fruit for snack. The childminder organises the environment, so it is safe for children to play. Children are comfortable with the childminder. The childminder regularly shares information with parents and carers. They comment that they are happy with how the childminder cares for their children.

#### **Outcomes for children are inadequate**

Children do not make sufficient progress in their learning and are not developing the skills they need for their future development or move to school.
