# Summary of key findings for parents

## This provision is good

- The childminder plans and promotes children's learning well. This helps them to make good progress from the start.
- The childminder maintains successful working partnerships with the other settings children attend. This promotes their well-being and development consistently.
- Children form warm and trusting relationships with the childminder and her family. They are keen to share their news with them and exchange lots of laughter and affection.
- Children benefit from daily outdoor play. For example, they play in the garden and go on local walks to develop physical skills and learn about the natural world.
- The childminder has addressed the recommendation from the last inspection successfully. She accurately monitors children's learning in all areas and keeps parents updated of their progress and planned next steps for learning.

# It is not yet outstanding because:

- The childminder does not always provide time in some creative and reading activities for children to explore and follow their interests in order to promote their independent learning further.
- The childminder does not consistently obtain information from all parents about their children's development at home to extend children's learning further.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- encourage children to follow their ideas and choices consistently in all activities to extend their independent learning even further
- strengthen partnerships with parents by encouraging all parents to share information regularly about their children's learning at home.

- The inspector observed the management of children's care routines.
- The inspector looked at children's assessment records.

# **Inspection findings**

## Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder has a good understanding of her role and responsibilities to promote children's welfare. She attends ongoing courses to help her gain an even greater understanding of how to protect children and how to respond in the event of a concern about a child. The childminder attends regular training courses, workshops and childcare conferences to extend her knowledge of how children learn further. She uses this information to help children make even better progress, particularly in their communication and language, and literacy development. The childminder uses self-evaluation to monitor and make improvements to the quality of her provision.

## Quality of teaching, learning and assessment is good

The childminder promotes children's learning and development effectively. She plans activities to help each child achieve their next steps for learning. The childminder interacts in activities to support and engage children. She asks children questions to encourage them to listen and communicate, and respectfully allows time for children to think and answer. The childminder skilfully includes challenges in children's play and exploration to promote different aspects of learning. For example, she encourages younger children to count, name shapes and colours, and to learn new words to extend their vocabulary.

## Personal development, behaviour and welfare are good

The childminder works closely with parents to settle children and meet their care routines consistently. She provides a warm and welcoming home with a good range of activities for children to explore. The childminder maintains safe and secure play areas in which she guides children well on how to keep safe from harm. Children respond positively to the childminder's close support, re-assurance and encouragement, and they move around to explore freely. The childminder encourages children to manage many tasks themselves to develop good independence. For example, children learn to dress themselves, manage their meals and tidy away toys.

#### **Outcomes for children are good**

Children are curious and motivated learners who maintain attention well in activities that interest them. They make good progress and develop good self-confidence, independence and positive social skills to prepare them effectively for their future learning and starting school.
