Summary of key findings for parents

The provision does not meet requirements

- The childminder does not fully understand or meet the safeguarding and welfare requirements of the Early Years Foundation Stage with regard to employing assistants.
- The childminder did not provide Ofsted with information about a person who worked in her home and had unsupervised access to children, to enable suitability checks to be carried out. This failing also relates to the requirements of the Childcare Register.
- The childminder has undertaken first-aid training but has not ensured that her assistant held a first-aid certificate when left alone in charge of children.
- The childminder has a limited knowledge of the learning and development requirements, and the areas of learning. She is unable to assess children's progress and plan activities that meet their individual needs to help children to be ready for school.
- The childminder understands the need to promote children's physical, personal and social development. She understands the importance of managing children's behaviour and of teaching them to respect others.
- The childminder understands her responsibility to report any concerns about children's welfare.
- The childminder knows the importance of working in partnership with parents and other relevant professionals.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage and the Childcare Register the provider must:

- The inspector looked at the areas of the childminder's home which are available for childminding purposes, and the resources for children's use.
- The inspector checked documentation required to meet the requirements, such as a valid paediatric first-aid certificate and public liability insurance.
- The inspector discussed with the childminder her knowledge and understanding of safeguarding children, and what she would do in the event of a concern.
- The inspector discussed with the childminder her understanding of the Early Years Foundation Stage and how she will promote children's learning.
- The inspection took place following concerns raised relating to persons working in the childminding setting.

The childminder registered in 2014. She lives in Chingford in the London Borough of Waltham Forest. The childminder operates from Monday to Friday, from 8am until 5pm, all year round, except for bank holidays and family holidays.
