## Summary of key findings for parents

#### The provision meets requirements

- The childminder has a range of toys and equipment suitable for supporting the play and development of children in the early years age range.
- Policies and necessary paperwork outlining appropriate working practices are in place, including risk assessments and forms for recording accidents.
- The childminder has a thorough knowledge of how to keep children safe and is aware of the indicators that may cause concern about a child's welfare. She knows the procedure to follow to report any concerns that arise.
- The childminder discusses routines, such as settling in, with parents so that children are settled at their own pace. Information about the children's day is discussed with parents so that they are fully informed about what their children do.
- The childminder understands how to support children's health and well-being. For example, she discusses the importance of eating fruit and vegetables with the children.
- Respect for different cultures is promoted as the childminder provides activities to engage children in cultural festivals and celebrations.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
