# Summary of key findings for parents

# This provision is good

- Children are happy and have positive attitudes to learning. They behave well and respond appropriately to instructions.
- Staff interact well with babies and help them explore different resources and tools. Babies have plenty of space to crawl and walk safely. They smile and squeal happily, and make good progress in their language and physical development.
- Children of different ages make good progress in relation to their starting points and capabilities. Teaching is strong and enables children to achieve well. Children are ready to move to the next stage of learning.
- Children have access to a range of activities and materials to help them learn about the different people, their cultures and traditions.
- Staff work collaboratively with outside professionals to ensure that disabled children and those who have special educational needs receive the individual support they need and help them catch up.
- Management regularly monitors and evaluates the provision to ensure the nursery continually maintains a good-quality service.

## It is not yet outstanding because:

 Occasionally, staff do not challenge the most able children to encourage independent problem solving and to further extend their language skills.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

provide even more learning experiences to challenge older children to further extend their language and solve problems independently.

### **Inspection activities**

- The inspector observed activities in all parts of the nursery, including the outdoor provision.
- The inspector spoke to some members of staff and children at appropriate times during the inspection and held meetings with the nursery management team.
- The inspector carried out joint observations with the manager.
- The inspector took account of the views of parents spoken to during the inspection and reviewed parents' questionnaires, written comments and suggestions.
- The inspector looked at children's records, planning documentation and the nursery's policies and procedures, including those related to the suitability of staff.

# **Inspection findings**

### Effectiveness of the leadership and management is good

Management observes staff regularly and sets challenging targets to help them improve their practice. They check individual children to ensure they make good progress. Staff attend training courses and observe one another teach to improve their skills. They keep parents fully informed about their children's progress and well-being. Staff suggest ways that parents can support their children's learning. Staff work well with other settings to help children settle smoothly when they move on. Safeguarding is effective. The provider ensures staff are suitable to work with children. Staff have received relevant training in safeguarding and are clear about the reporting procedures. Management seeks the views of staff, parents, children and others to improve outcomes for children.

## Quality of teaching, learning and assessment is good

Staff use observations and assessments well to continually plan interesting activities and experiences. This information, along with details parents provide, allows staff to monitor children's progress. Children play together in harmony. They are highly engaged in activities and are confident to ask for help. Children use various resources to make their own models, using creativity in their play. Staff give children enough time to explore resources and intervene when necessary to support their learning. Children enjoy story time and songs and comment on events and characters. Children explore different musical instruments and dance to the sounds they make. Staff talk to children and act on their suggestions to promote their communication skills.

#### Personal development, behaviour and welfare are good

Staff have good relationships with children and help them differentiate right from wrong. They encourage children to serve their own food and pour their drinks independently. Children enjoy the relaxed social occasion where they eat and talk to one another. Staff support children's understanding of healthy eating habits. Children have access to outdoors to have fresh air and exercise. They show care for their environment, for example, children who find resources on the floor or in the cloakroom pick them up and give them to staff to put away. Staff conduct regular checks on the premises and resources to ensure children can engage in both outdoor and indoor activities safely. They teach children how to handle resources with care and to show consideration to others.

### **Outcomes for children are good**

All children make good progress and any gaps in learning are closing rapidly. Babies learn new words and try different activities. Older children learn to share resources fairly and to take turns. Children learn the skills they need to prepare for the move to school.

Happy Tree (West Drayton) registered in 2010. It is situated in West Drayton, in the London Borough of Hillingdon. The setting is open each weekday from 7.30am to 6:30pm, 50 weeks a year.
