Summary of key findings for parents

This provision is good

- The childminder sets high expectations for herself and the children. She has a secure understanding of how to meet the requirements for the Early Years Foundation Stage.
- The childminder provides children with an interesting range of learning activities and toys that help them to make good progress. She gives good emphasis to promoting children's communication and language skills.
- Children's emotional development and well-being is promoted well. The childminder has established a warm rapport and positive relationships with the children. They grow in confidence and become increasingly independent. Children are well behaved.
- The childminder ensures that children are safe and secure in her home and on visits.
- The childminder reflects on her practice and takes effective steps to make necessary improvements.
- The childminder has established positive partnerships with parents, who are pleased with the care provided.

It is not yet outstanding because:

- Children do not have good opportunities to practise mark making and early writing skills.
- There are not many activities planned to help children to think for themselves and to solve problems.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- extend opportunities for children to practise their early writing skills
- provide more activities that encourage children to think for themselves and to solve problems.

- The inspector examined a range of documentation, including children's learning records and documents relating to safeguarding.
- The inspector completed a joint observation with the childminder.

Inspection findings

Effectiveness of the leadership and management is good

The childminder sets high expectations for herself and children. She ensures that children are well cared for and make good progress. Safeguarding is effective. The childminder attends regular safeguarding training and has a secure understanding of how to protect children. She knows the procedures to follow in the event of any safeguarding concerns. The childminder reflects on her practice, including seeking the views of parents. She takes steps to bring about improvements where needed. For example, at parents' request, the childminder now takes children on more visits. The childminder has positive partnerships with parents and understands the need to work alongside other settings and schools when children's care is shared with others.

Quality of teaching, learning and assessment is good

The childminder shows a secure understanding of how young children learn. She gains a clear understanding of children's skills when they join the setting and uses effective ongoing observation and assessment to monitor children's progress. She provides interesting activities suited to children's ages and individual learning needs. The childminder develops children's communication and language skills well. For example, she repeats new words, sings songs, tells nursery rhymes and asks questions about characters. Children make good progress in selecting numbers of items and exploring with shapes. There are good opportunities for them to be creative and to develop physical skills. The childminder keeps parents well informed about their children's progress.

Personal development, behaviour and welfare are good

The childminder provides a welcoming and positive environment for children. She has established a close bond with the children in her care. Children are happy and secure with the childminder. They gain in confidence and become increasingly independent when choosing toys and relating to others. They respond well to the childminder's clear expectations of behaviour. The childminder promotes the importance of healthy lifestyles well and children benefit from healthy snacks and regular exercise. Children enjoy picnics in the park with other children and their childminders, and develop their social skills well.

Outcomes for children are good

Children make good progress in their learning and in their personal development from their starting points. Children gain skills that prepare them well for the next stage of their learning and school.
