Summary of key findings for parents

The provision meets requirements

- The childminder knows how children learn and what activities to provide that help children make progress.
- She understands the importance of sharing children's achievements with parents and tracking the development that children make.
- The childminder keeps up to date with safeguarding practices. She knows how to identify concerns about children's welfare and who to contact.
- The childminder is aware of how to prepare children for the next stage in their learning.
- The childminder understands how to help children behave well and learn to respect one another.
- The childminder understands the importance of reflecting on her practice to identify strengths and any areas for development. She would seek the views of parents and children to ensure a thorough evaluation process.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
