Summary of key findings for parents

The provision meets requirements

- The childminder knows how to monitor and reflect on her practice. She understands the significance of working with parents and children and gathering their views, and how this will help to improve her childcare practice.
- The childminder understands her responsibility to report any child protection concerns and to keep suitable records with regard to safeguarding.
- The childminder knows how to plan activities that help children have fun as they learn. She has an extensive range of toys and resources to meet the differing ages and abilities of the children.
- The childminder keeps the relevant and appropriate first-aid training up to date. This helps her to respond to accidents and emergencies that may arise.
- The childminder is aware of the need to work with parents to gather and maintain records with relevant details of the children she cares for and how to use this information to help children feel safe and secure in her care.
- The childminder understands the importance of a healthy lifestyle for children, and how to promote this through clear messages about fresh air, exercise and diet.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector sampled some of the documentation that the childminder has to support her work.
- The inspector and the childminder discussed her methods of assessing children's progress and her planning for children's development.
- The inspector and the childminder discussed the childminder's self-evaluation systems and her improvement plan.
- The childminder discussed how the childminder keeps children safe and her understanding of safeguarding.
- The inspector viewed the spaces, toys and equipment available for childminding purposes.

The childminder registered in 1994. She lives in the London Borough of Brent. The childminder works each weekday, term time only. At the time of the inspection, there were no children on roll in the early years age range.
