- The childminder's teaching is excellent. She checks on children's progress thoroughly to help identify opportunities to challenge and extend children's individual learning needs.
- The childminder has highly effective partnerships with parents that promote a fully joined-up approach to meeting children's needs. Children benefit significantly from the ongoing and detailed flow of information between their main carers.
- The childminder is passionate about her role. She rigorously evaluates all aspects of her practice and continually makes improvements to benefit all children.

# **Inspection findings**

### Effectiveness of the leadership and management is outstanding

The childminder is highly experienced and professional. She provides children with the best possible opportunities to learn in nearly all areas, to develop and reach their potential. The environment for children is highly stimulating and they have access to an extensive range of resources. Safeguarding is effective. The childminder gives high priority to keeping children safe and has an excellent understanding of how to safeguard children's welfare. Parents comment highly about the childminder's provision and state she is a 'fantastic childminder'. The childminder is extremely proactive in continuing with her own professional development to extend her knowledge of Early Years practice. She applies what she learns to her teaching and the planning of activities. She recognises, however, that there is room for further improvement to enhance aspects of children's learning of science and technology.

### Quality of teaching, learning and assessment is outstanding

The childminder has a comprehensive knowledge of children's stages of development, gained through observation of their play. She pays extremely close attention to checking upon their learning, so she can address any gaps in their achievement. All information about children's development is shared with parents to keep them fully informed and involved with their children's learning. The childminder provides children with an extensive variety of activities, which keep them highly stimulated and engaged. Children are very confident speakers. They correctly and spontaneously count, and develop a wide vocabulary, for example, as they listen to the childminder name unfamiliar objects during play and different activities.

## Personal development, behaviour and welfare are outstanding

Children have secure and close attachments to the childminder. They thrive in her care. Children's familiarity with her home and daily routines gives them high levels of confidence to independently explore. They show great care and concern for one another. For example, children help each other dress for outdoor play and older children tenderly touch babies and give them toys. Children develop an excellent understanding of health and safety practices. For example, they know they must wash germs off their hands before eating and choose healthy options, such as fruit for snack time. They have excellent daily opportunities to aid their physical development during outdoor play, using the climbing frame and slide carefully.

#### **Outcomes for children are outstanding**

Children are extremely confident and show high levels of motivation to learn as they eagerly and actively engage in play. They make excellent progress from their starting points as they develop the skills they need for starting school.
