# Summary of key findings for parents

## This provision is outstanding

- The staff team plans an excellent range of exciting, thoughtful and challenging activities which are based on children's interests. As a result, children have great fun and thoroughly enjoy their time at the club.
- The well-considered deployment of staff and highly effective organisation of activities enable children to make consistently independent choices about their play.
- Staff have excellent working partnerships with parents and others who work with the children. They exchange information quickly and easily to ensure that all children's care and learning needs are known and met consistently by all staff.
- Parents are extremely happy with the club. They receive a wide range of information which keeps them up to date about the activities provided and what their children have enjoyed.
- Children develop excellent social skills. They are exceptionally confident and are respectful towards each other and staff. Staff are very positive role-models.
- Children's behaviour is exemplary. They are fully aware of their boundaries and understand how to behave in ways which keep themselves and others safe. They develop close relationships and often help others.
- Self-evaluation is outstanding. The provider constantly seeks, evaluates and acts on the views of parents, staff and children to drive continuous improvement.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

continue to build on the superb targeted programme of professional development to further enhance the practice of the highly skilled staff team.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The provider is driven and dedicated to her role. Rigorous evaluation and reflection mean the provider is fully up to date on any changes to requirements or government policy. She fully considers the views of children, parents, staff and the school to maintain continuous improvement that benefits all children. The provider works closely with local authority advisors to swiftly address any recommendations. Parents comment that their children thoroughly enjoy the club's activities; they appreciate the exceptionally high-level of care that their children receive. The provider supports the staff team extremely well through regular and focused staff meetings, training and supervision. She is continually looking at ways she can receive additional, specialised staff training and intends to continue their professional development. Staff implement their policies and procedures securely and promote children's safety, health and well-being extremely well. Safeguarding is effective. The provider ensures staff have an excellent understanding of child protection matters. Robust recruitment and rigorous vetting procedures ensure staff are suitable.

## Quality of teaching, learning and assessment is outstanding

Children flourish because the imaginative, well-planned range of enjoyable activities sustains their interest, keeps them engaged and effectively complements their learning at school. They thoroughly enjoy playing in small groups and talking to each other about their play. Staff join in children's play extremely well and encourage language development through interesting conversations, for example. Children become totally absorbed in their activities and demonstrate high levels of focus and engagement. There is plenty of space for children to freely and confidently move around and explore both inside and outside. Staff consistently focus on children's individual needs. As a result, children enjoy their time at the club and are eager to attend.

## Personal development, behaviour and welfare are outstanding

Staff prioritise children's well-being. All children settle well and are very content. They develop confidence, independence and self-control during their activities. Staff consistently praise children and have high expectations of their behaviour, which are reinforced with clear and simple rules that the children understand. Staff acknowledge equality and diversity positively. They listen to children and know them extremely well. Children thoroughly benefit from regular physical activities, where they can learn new skills, manage risks and explore new interests through their play. Children learn the importance of healthy lifestyles. For example, they participate in a range of very good hygiene practices and consolidate their learning through high-quality discussions.
