Summary of key findings for parents

This provision is outstanding

- The partnerships with parents are exceptional. The childminder has outstanding relationships with parents that enable frequent exchanges of information about children's care and learning.
- The childminder knows the children extremely well and places a high priority on promoting their confidence and emotional well-being. Children are confident and highly motivated to engage in the stimulating activities. They have an excellent relationship with the childminder and each other.
- The childminder is extremely reflective about her practice. She seeks the views of parents and children to help her to identify areas for ongoing improvements.
- Safety is an exceptionally high priority for the childminder. She carefully follows extremely good, detailed risk assessments that are highly effective at minimising hazards to children.
- The childminder has an excellent and thorough knowledge of how to safeguard children. She has a comprehensive understanding of how to manage any child protection concerns she may have about their welfare.
- The childminder uses her extensive knowledge to support parents and complement children's ongoing learning at school extremely well.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder makes excellent use of relevant training to ensure she has up-to-date information to help keep children safe. Parents speak very highly of the childminder, praising the service she provides. The well-qualified childminder is highly organised and has a highly effective understanding of her responsibilities. She is proactive at engaging with other early years professionals to discuss and maintain the best possible practice. The childminder extends her excellent knowledge of childcare, for example, from a wide variety of training courses and reading relevant publications. Through her excellent self-evaluation, the childminder recognises children's interest in technology. For example, she intends to implement plans that increase their engagement and fun with the computer.

Quality of teaching, learning and assessment is outstanding

The childminder works effectively with the school and has an outstanding understanding of children's abilities and areas of development. For example, she extends children's interests in literacy and numeracy exceptionally well as they play games. Children flourish and have total engagement, for instance, as they pay extremely close attention to their activity and complete games with immense satisfaction. The childminder makes exceptional use of her communication skills. For example, she extends children's vocabulary and encourages excellent discussions about the school day or weekend events.

Personal development, behaviour and welfare are outstanding

Children thrive in the childminder's exceptional care where they feel valued and respected as individuals. They behave extremely well. The childminder is an outstanding role model who provides children with consistency in care and clear expectations for positive behaviour. She has comprehensively met her previous recommendation. She increased her resources and activities to help children develop an excellent understanding of people's similarities and differences. For example, children had the opportunity to see, feel and discuss a book written for the blind. Children learn the importance of having a healthy lifestyle. For example, they grow fruit and vegetables in the garden and thoroughly understand the need to wash them before they eat them.
