## Summary of key findings for parents

#### This provision is good

- The childminder is proactive in using information available to raise the achievements of each child in her care. Children develop strong bonds and secure emotional attachments with the childminder, who is highly attentive to their care needs.
- The childminder has developed very effective arrangements for working in partnership with other early years professionals to identify and address children's needs.
- Assessment covers all areas of children's learning and development and informs the childminder's planning. Activities support each child's individual learning and emotional well-being. Children make consistent good progress from their starting points.
- The childminder has a good knowledge of safeguarding and the procedures to follow to report a child protection concern. She promotes children's safety in her home and on outings through her detailed risk assessments and daily vigilance.
- Partnerships with parents are excellent. The childminder uses a range of information sharing practices to engage parents in their children's learning, and build on children's interests and achievements from home.

#### It is not yet outstanding because:

- Occasionally, the childminder does not fully challenge children's learning and thinking skills. She sometimes focuses more on what children are learning than reflecting on how they are learning.
- Planned creative activities do not always extend children's thinking and imagination.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- raise teaching skills further by evaluating how children learn most effectively, as well as what they learn and achieve
- review how to enhance children's imaginative play and creative skills even further.

#### **Inspection activities**

- The inspector observed care routines and teaching, and the impact of these on children's safety, welfare and learning.
- The inspector reviewed policies and discussed the procedures relating to children's safety and welfare with the childminder.
- The inspector looked at children's records, the childminder's planning and evaluation of activities, and information exchanged with parents.
- The inspector took account of the views of parents' written communication.
- The inspector spoke with the childminder about the impact of her training, experience and practice on children's well-being, learning and development.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

The childminder is experienced, kind and capable. She aims to provide good quality care and learning for children. Children and their parents contribute their views to the childminder's evaluation of her services. This helps her to continue to make improvements, for example, to the way she works with parents, the accessibility and choice of toys, and how she monitors children's achievements. Safeguarding is effective. The childminder conscientiously uses detailed records, policies and procedures to promote all aspects of children's health and safety.

#### Quality of teaching, learning and assessment is good

Children make consistently good progress in their learning and development. They are socially confident and communicate well for their ages. The childminder has a thorough understanding of each child's interests and abilities. She uses regular, precise assessments, and works effectively with parents to identify and target children's next steps in learning. The childminder prepares wonderful craft activities to help children learn about a diversity of cultural celebrations. She gives children an excellent start in early mathematics and literacy. For example, she encourages children to fit inset puzzles, sings rhymes, and links sounds with initial letters in familiar words.

#### Personal development, behaviour and welfare are outstanding

Children are very happy and confident to try new activities. The childminder consistently promotes positive behaviour and provides children with clear explanations that they soon understand. She sensitively encourages children to value and respect each other. Her home is extremely welcoming. Children look forward to their time meeting friends each day and their adventures at toddler groups. Children learn to keep themselves safe and healthy, for example, as they sit together at the table, share news and try new fruits and vegetables. Children have superb opportunities to take part in challenging physical and outdoor play. For example, they regularly explore different parts of their community and local environment.

#### **Outcomes for children are good**

Children make good progress in their learning and development. They acquire the essential skills that they need in readiness for nursery and school.
