Summary of key findings for parents

The provision does not meet requirements

- The childminder does not hold a current paediatric first-aid certificate. This is also a breach of the Childcare Register requirements.
- The childminder knows how to provide and plan stimulating activities for indoor and outdoor play. She has a range of suitable toys and resources to promote children's all-round learning and development.
- The childminder knows how to monitor and track children's progress and link them to the areas of learning to help children make good progress.
- The childminder understands how to promote children's safety and take precautions to prevent accidents.
- The childminder understands her role in establishing effective relationships with parents and other settings, to complement children's learning and create a consistent approach.
- The childminder understands her role in promoting children's good behaviour and well-being to help them prepare for their next stage of learning, or school.
- The childminder has addressed the recommendation set at the last inspection and continues to evaluate her practice to raise standards.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

The childminder registered in 1992. She lives in the London Borough of Merton. The childminder operates term time only from 8am to 6pm, Monday to Friday. The childminder holds a relevant early years qualification at level 3. There were no children on roll at the time of inspection.
