# Summary of key findings for parents

## This provision is outstanding

- The childminder provides all children with a wealth of high-quality toys and resources to support them to be actively involved in their learning.
- The childminder and her assistants have fostered excellent relationships with the families that use the service. They have extremely impressive settling-in procedures, which enable children to develop very strong bonds with adults.
- The childminder has high expectations for her setting. She continually updates her already outstanding knowledge and skills. She supports her assistants to improve their qualifications and training, to promote positive outcomes for all children.
- The childminder is extremely well organised and has in place first-rate systems to monitor children's development. She ensures all children are making superb progress in their learning.
- Children benefit from an excellent range of opportunities to exercise and explore in the fresh air. The childminder supports children to develop their physical skills and learn about healthy lifestyles extremely well.
- The childminder has an in-depth knowledge of the safeguarding and welfare requirements and is very clear about her role, and that of her assistants, in keeping children safe and secure at all times.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder has robust systems in place to support her assistants. She ensures that they understand policies and procedures, and receive the required training to safeguard children and their families. She is exceptionally conscientious in the way she monitors and supervises children's learning. The childminder has forged extremely effective associations with other professionals to support children moving on to schools and nurseries. Exemplary relationships between the childminder and parents ensure that parents are constantly kept up to date with details about their children's progress. The childminder has highly impressive self-evaluation procedures. She takes into account the views of parents, children and her assistants, to help enhance her practice.

## Quality of teaching, learning and assessment is outstanding

The childminder offers children an environment that is highly stimulating. All children are actively engaged in their play and have positive attitudes to learning. Children have excellent opportunities to explore new ideas and experiences. They are confident learners who are encouraged to use their imagination and develop their problem-solving skills. However, on occasion, the teaching assistants are not fully confident in knowing how to extend children's learning even further. The childminder makes very effective use of books and natural resources to help children learn about the world around them. For instance, they watch chicks hatch and care for them as they grow. Children's listening and speaking skills develop tremendously well. They make outstanding progress in their communication and language development.

## Personal development, behaviour and welfare are outstanding

All children are industrious and extremely at ease in the childminder's care. She prepares fresh, nutritious, home-cooked meals for children, to help them learn how to have a healthy diet. The childminder provides many valuable opportunities for children to socialise. For example, they go on numerous trips to parks, libraries and the beach. They meet with friends regularly, which helps support their personal, social and emotional development. Children enjoy joining in with local events to learn about their community. The childminder and her assistants are very positive role models for children. They reinforce excellent behaviour, for example, through extensive praise and encouragement. Children gain an exceptional understanding of how to manage their own behaviour. The childminder encourages children to acquire excellent hygiene skills from a young age.

#### **Outcomes for children are outstanding**

Children make excellent progress in their learning from their initial starting points. They are exceptionally confident, enthusiastic learners who have the skills needed for the next stage in their development and eventual move to school.
