Summary of key findings for parents

The provision meets requirements

- The childminder understands how to monitor, assess and track children's progress and how to use information gained to plan activities to promote all areas of their learning.
- The childminder has a safe and well-maintained home. She knows how to promote children's health, for example by providing nutritious foods and regular exercise.
- The childminder is aware of her duty to safeguard children. She understands the procedures to refer any causes of concern and the importance of working in partnerships with other professionals and parents.
- The childminder keeps her training up to date and is committed to improvement by reflecting and evaluating on her practice.
- The childminder has a good range of toys and equipment suitable for supporting the play and development of children in the early years age range.
- The childminder knows how to build good relationships with parents, keeping them up to date with their children's learning, for example through meetings, reports and parents' events.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector looked at relevant documentation, including policies, contracts and accident forms.
- The inspector spoke with the childminder about her arrangements to care for children in the early years age range.
- The inspector looked at the suitability of the environment and toys and equipment available for use with children.

The childminder registered in 1999 and is based in Hounslow in the London Borough of Hounslow. The childminder has an early years qualification at level 3. She offers care all year round. There were no children in the early years age group on roll when this inspection took place.
