Summary of key findings for parents

This provision is outstanding

- Children's safety and safeguarding is central to everything the childminder does. She implements an excellent range of policies, procedures and daily practices to promote children's health, safety and well-being. The childminder shares and discusses these with parents and diligently maintains records to monitor all aspects of her work.
- Children soon feel extremely secure and they flourish in the childminder's care. She takes time to get to know their individual personalities and sensitively responds to their specific needs.
- The childminder keeps a close check on what children can do. She quickly recognises when a child is not achieving as well as they might and swiftly provides them with the support they need. Children make rapid progress in their learning and development from their individual starting points.
- Children thoroughly enjoy learning and make excellent progress. They eagerly join in activities and relish using the excellent range of resources to explore and experiment.
- The childminder consistently praises children's efforts and achievements so they are keen to try and persevere with new experiences. They are increasingly independent as they develop skills that prepare them extremely well for the next stage in their learning.
- The childminder gives parents a very clear picture of their children's daily play and next steps in learning. Parents quickly share the joys of their children's latest achievements.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

extend the strong programme of professional development even further to ensure that practice continually improves, to maintain outstanding outcomes for children.

- The inspector reviewed policies and discussed the procedures relating to children's safety and welfare with the childminder.
- The inspector looked at children's records, the childminder's planning and evaluation of activities, and information exchanged with parents.
- The inspector took account of the views of parents in written communication.
- The inspector spoke with the childminder about the impact of her training, experience and practice on children's well-being, learning and development.

Inspection findings

Effectiveness of the leadership and management is outstanding

Children show great enthusiasm for learning in the care of this experienced and highly capable childminder. Routine reflection on the impact of her teaching and evaluation of all aspects of her provision underpin the childminder's success in driving her practice to an outstanding level. Her next challenge is to explore a wider range of avenues to help her sustain the excellent quality of teaching and exemplary outcomes for all children. Safeguarding is effective. The childminder knows what to do if she has concerns about child protection. She is swift to implement guidance from her Local Safeguarding Children Board and her local authority adviser. The childminder is very conscientious about safety. For example, she makes detailed risk assessments and uses these to make her home, garden and outings into the community safe environments for children to play and learn.

Quality of teaching, learning and assessment is outstanding

Children benefit from consistently high-quality teaching. The childminder is extremely effective in monitoring children's progress and skilfully matches an inspiring range of learning experiences to children's specific needs and interests. For example, children demonstrate their joy and delight as they play with their favourite coloured balls as the childminder enables them to quickly learn new vocabulary. They laugh together as they take turns to repeat key words. The childminder's plans to nurture the next steps in children's learning are precise and promote each child's development exceptionally well. She uses an exemplary range of strategies to develop children's early literacy, numeracy and technical skills using simple, carefully chosen toys and imaginative games.

Personal development, behaviour and welfare are outstanding

Partnerships with parents are exceptional. Highly effective communication and settling-in sessions help the childminder to know the children's needs extremely well. The childminder uses her extensive professional network and undertakes training to challenge and extend her practice. For example, she is alert to potential risks to children when they are exploring the world around them and teaches children ways to help manage these safely. The childminder provides an exciting range of toys in her garden that inspire children of different ages to strengthen muscles, work as a team and nurture plants and insects. The childminder has a calm and positive manner. She models effective ways for children to resolve differences respectfully and to develop positive, trusting relationships.

Outcomes for children are outstanding

Children have a fantastic time and gain a wealth of skills across all areas of learning. They develop positive attitudes to learning, listen carefully and play enthusiastically. Children make excellent progress and are socially and emotionally ready to master new challenges at nursery and school placements.
