This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged **Good** at the full inspection. At this interim inspection Ofsted judge that it has **sustained effectiveness**.

Young people at this home, who were previously finding it difficult to engage in education, are now regularly attending their education provision. Although young people can be reluctant to attend, they are well supported in identifying education that is suited to their needs and therefore make progress in this area. For example one young person has completed their statutory education and is enrolling on a Duke of Edinburgh award scheme and looking at Prince's Trust courses.

Some young people at this home are at high risk of child sexual exploitation (CSE) when initially placed. Their risks reduce over time and they are well supported to understand how to keep themselves safe. Their risk assessments are updated accordingly and the most recent risk assessments are recorded on their files. Internet use and on line safety is given thorough consideration and young people have only supervised access to the internet and social media at present. Similarly age restrictions on computer games are adhered to, even when young people bring 18 rated games into the home from previous placements. Unsuitable games are sensitively 'traded' for age appropriate games.

Self-harm was a significant issue for young people at this home and there have been no incidents since the last full inspection. This is due to the increasingly settled behaviour of the young people and the positive and trusting relationships young people develop with staff members. The home has good links to external support agencies in respect of maintaining positive emotional health and young people receive a holistic package of support in this area. Additionally the home works in partnership with health agencies and young people engage well in maintaining their general health and wellbeing.

The relationships between the young people are becoming more settled, with fewer incidents of negative behaviour. The addition of a third young person into the home has been well planned and managed and has had a positive impact for all young people placed. Complaints from neighbours about the level of noise have ceased and this is due to less verbal aggression between the young people and fewer episodes of challenging behaviour within the home.



Young people's behaviours are very well understood and any unsettled behaviour usually has an identified trigger and is dealt with sensitively in a supportive rather than punitive manner. Young people can identify a trusted adult who they feel comfortable in talking to about issues and concerns, which results in fewer incidents of aggression or self-harm. Key worker support is valued by the young people and they are able to express their views about their choice of key worker; this ensures they have a key worker who they have a close and trusting relationship with and that they know their views are listened to.

There have been no missing from home episodes and no physical management of behaviour which contributes to young people's feeling of safety. There has been one allegation made against a member of staff which is currently under investigation. The home is working well with the LADO and is following all statutory policies.

The home has been without a Registered manager for 18 weeks. The current acting manager has made an application to the regulator for registration, but unfortunately will be going on extended leave necessitating a further temporary manager being recruited by the company.

One requirement made at the previous inspection in respect of CSE risk assessments has been met. The requirement in relation to recruitment has not been met, with recruitment files not containing all the necessary identifying documents for employees, this requirement is therefore repeated at this inspection.

Young people are making good progress across all areas in this home, with significant progress noted in some specific areas for some young people. This is balanced with the changes to the registered manager position, the serious allegation under investigation and the unmet requirement, resulting in a judgement of sustained effectiveness.



Information about this children's home

This privately owned children's home is registered to accommodate and care for four young people of either gender aged between 11-17 years. Young people accommodated experience emotional and behavioural difficulties. The home accepts emergency placements and can offer care to young people on a short, medium or long term basis.

In addition the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people who it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.
