Summary of key findings for parents

This provision is outstanding

- The childminder is a skilled teacher. She continually stimulates and extends children's learning and successfully helps children to achieve at the highest levels. Any gaps in children's learning are identified and swiftly addressed. The childminder is an exceptional role model to children. Her practice is worthy of dissemination to other practitioners.
- The childminder has consistently high expectations of children and they make excellent progress. Children acquire a great deal of in-depth knowledge about the natural world. They enjoy sharing what they know with adults and have a thirst to learn more.
- The childminder develops highly effective partnerships with parents and other settings that children attend. This promotes very high levels of continuity in children's care and learning.
- Children thrive and become extremely confident and independent because the childminder is very skilful in promoting their well-being. Children develop very high levels of self-awareness and consideration for others. They recognise their emotions and those of others and link these to their own feelings and experiences.
- The childminder uses her bilingual skills extremely well to support children who speak English as an additional language. Children develop and use their home language to reach a very high standard in speaking English.
- The childminder continually seeks to improve her practice. She seeks and responds to best practice guidance and parents' and children's views. She provides children with the best care and learning experiences.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder has an exceptional level of knowledge and understanding of how to help children reach their potential and achieve at the highest level. Comments from parents demonstrate the significant positive contribution the childminder makes to the lives of children who attend. Parents say their children have become very confident and talkative. They say they feel very supported to help their children and well informed about their children's progress. The childminder is extremely effective in evaluating all activities and recognising how she can make continuous improvements to build upon her already first-rate practice. For example, she currently has well-targeted plans in place to develop her garden to further enhance children's outdoor play experiences. Safeguarding is effective. The childminder has attended child protection training events. She has a high level understanding of child protection issues and procedures. Children are kept safe and secure at all times.

Quality of teaching, learning and assessment is outstanding

Teaching is consistently of a very high standard. The childminder ignites children's enthusiasm and drive to learn. She shows children how to be inquisitive and find things out. She has a deep understanding of what children need to learn next and how she can help them to achieve this as quickly as possible. Children use exceptional levels of detail and accurately sequence events when they recall experiences. They use what they already know and understand to further extend their learning. Children's vocabulary is extensive, for example, they talk about the different shade of colour and complex shapes. Children measure time and objects and complete simple calculations. They compare and give their explanations for the differences they see. Children make models and pictures using their creativity and imagination. They show high levels of interest and continually develop their competency in forming and hearing sounds in letters.

Personal development, behaviour and welfare are outstanding

Children are inquisitive about what they see, hear and feel. They are highly motivated to find explanations and to solve any problems they encounter. Children who begin with lower levels of self-confidence and social skills receive exceedingly effective support to make substantial progress. Children are polite and well behaved. They express themselves extremely well. Children are continually developing their understanding of how to keep themselves safe. Their understanding of healthy eating and the journey of food from source to the table is exceptional. Children's diverse family experiences are valued and celebrated. Children demonstrate positive attitudes to the similarities and differences they recognise in themselves and others.

Outcomes for children are outstanding

Children exceed the level of development that is expected for their age. They are exceptionally well prepared for their next steps in learning and school when the time comes. Children are highly motivated to find out why and how things happen. They are confident and competent communicators who enjoy planning and reviewing their learning.
