Summary of key findings for parents

This provision is inadequate

- The childminder does not have a sufficient understanding of her role and responsibility to notify Ofsted of changes to people who live at the premises where childminding takes place.
- The childminder is unclear about the amount of early years children she is able to care for at one time. As a result, she has not maintained the relevant ratio requirements for young children.
- The childminder demonstrates a limited understanding of the Early Years Foundation Stage learning and development requirements.
- The childminder does not use assessment to help identify children's starting points, monitor their progress or identify their current level of development.
- Children make some progress in their development. However, the childminder does not effectively plan challenging experiences to consistently extend and promote children's learning and development.

It has the following strengths

- The childminder provides a warm and welcoming environment for children. Children form secure, caring bonds with the childminder, helping to support their emotional development. Children exhibit good levels of self-esteem and confidence.
- The childminder shares information daily with parents about activities and experiences children enjoyed while in her care. She speaks with parents on a daily basis to promote continuity in children's care and learning and to establish a good relationship.

What the setting needs to do to improve further

Inspection findings

Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are not effective. The childminder has a limited understanding of the legal requirements. She has failed to notify Ofsted of changes to her household and does not consistently adhere to ratio requirement for younger children. This compromises children's well-being and puts their safety at risk. The childminder has a suitable understanding of child protection issues. She knows what action to take if she has any concerns. The childminder has completed required training and uses self-evaluation to identify weaknesses in the provision. However, she has failed to identify or address where her teaching skills and knowledge are inadequate. She has not maintained her professional development sufficiently. Opportunities to improve her knowledge, develop her practice and positively enhance outcomes for children have been missed. Partnerships with parents and other settings that children attend are effective. Parents compliment the care their children receive.

Quality of teaching, learning and assessment is inadequate

The quality of teaching is poor. The childminder does not assess children's progress effectively or plan activities to promote their learning. She carries out some observations of children. However, these are not used effectively to help her understand children's level of achievement, interests and learning styles, in order to shape future learning experiences. Consequently, children's experiences, although enjoyable, do not challenge them enough to help them make good progress towards their early learning goals. This means that much of the learning that takes place is incidental not planned. Children enjoy lots of independent choice and opportunities to initiate their own play. The childminder encourages children in their play and makes suggestions to keep them interested. She promotes their communication and language skills adequately. For example, she asks questions and encourages children to repeat the names of animals and shapes they see.

Personal development, behaviour and welfare are inadequate

The childminder's weak understanding of her responsibilities and breaches of requirements compromise children's safety and welfare. However, children feel at ease with her and regularly initiate cuddles. The childminder encourages them to share, take turns and develop their understanding of how to keep themselves safe. She manages behaviour appropriately and children behave well. Resources are of a good quality and children are able to initiate their own play and learning. However, poor teaching means that the childminder does not make best use of these resources to provide tailored learning experiences for children. The childminder encourages children to adopt a healthy lifestyle, providing opportunities for fresh air and exercise. She encourages children to eat the healthy options parents provide in their packed lunches.

Outcomes for children are inadequate

Children do not make good enough progress. Activities offer insufficient challenge as they are not planned or closely linked to children's individual learning needs. Therefore, children are not supported in the best possible way to prepare them for their future learning or the move to school.
