# Summary of key findings for parents

### This provision is outstanding

- Children benefit from inspirational teaching. The childminder has an excellent understanding of how children learn and develop indoors and outdoors. Children thoroughly enjoy exploring, and making choices and decisions about their play. They are extremely independent and confident, and develop an excellent range of skills for their future learning.
- The childminder assesses children's progress accurately. She monitors their achievements precisely to identify any gaps in their learning and development swiftly. She quickly puts support in place to help children catch up, so they make excellent progress from their starting points.
- Settling-in procedures are highly effective. Children have extremely close bonds with the childminder. These warm and very positive relationships clearly help children feel very safe and secure, and contribute highly to their well-being.
- The childminder has developed highly effective partnerships with parents and keeps them fully informed about their children's progress using a range of inspirational ways to communicate with them.
- The childminder monitors and evaluates all aspects of her practice rigorously in order to continually improve. She very successfully involves parents and children in helping to identify areas for her improvement.

# **Inspection findings**

### Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder has an excellent understanding of how to keep children safe and is extremely vigilant in her care. She is highly knowledgeable about the signs that would cause concern about children's welfare and the procedures to follow to make sure children are safe. The childminder is inspirational. She is dedicated to providing an exceptionally high-quality service to strengthen and improve children's outcomes. The childminder is committed to her professional development and constantly seeks to improve her already outstanding practice. For example, following training on supporting children with their communication development, she has provided activities that strengthen children's developing language skills, successfully helping the youngest ones to communicate their needs.

## Quality of teaching, learning and assessment is outstanding

The childminder has an in-depth understanding of every child's learning needs. She respects children's individuality and provides excellent opportunities and experiences to help them learn and progress at their own pace. She has meticulous arrangements for observing, assessing and tracking children's progress. She uses information effectively to plan precisely for children's next steps in learning. The childminder places the utmost priority on working with parents and other professionals to ensure children receive the support they need to flourish. She is highly successful at involving parents in their children's learning by sharing and giving them suggestions for lots of fun activities to do at home, although she does not always identify the learning aim of these to better support all parents.

### Personal development, behaviour and welfare are outstanding

Children develop a very strong sense of belonging, and flourish under the extremely positive and trusting relationships they have with the childminder. Children have an excellent understanding of the importance of a healthy lifestyle. They take part in growing their own fruit and vegetables on the childminder's allotment and take great delight in picking, cooking and eating these for their snacks and meals, and talking about why they are good for them. Behaviour is excellent and children show great respect to each other and other people.

#### **Outcomes for children are outstanding**

Children gain excellent confidence and self-esteem, and are extremely curious and motivated to learn and explore. They are highly social and work exceptionally well together to solve problems. They thoroughly enjoy using resources to re-enact favourite and familiar stories in their role play. The exceptional range of learning opportunities prepares them very well for the next stage in their learning and for their move to school.
