Summary of key findings for parents

The provision meets requirements

- The childminder attends safeguarding training and understands her role to follow procedures to safeguard and protect children in her care. She is aware of how to complete safety checks on her home and outings to ensure children remain safe.
- The childminder is aware of how to use observation, assessment and planning to promote children's continuous learning and help them make progress. She understands how to provide a balance of activities based on children's needs.
- The childminder understands how to manage children's behaviour in a suitable way so that they learn to behave well and respect others. She recognises the benefits of working closely with parents to support children's care and learning needs.
- The childminder knows how to reflect and evaluate on her practice, in order to update and improve the care and opportunities she can provide.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the childminder how she intends to deliver the educational programme for children.
- The inspector looked at the childminder's policies and documents she intends to use when caring for children.
