Summary of key findings for parents

This provision is inadequate

- Staff have insufficient knowledge and understanding of safeguarding procedures. They do not know how to identify the signs and symptoms that a child may be at risk of harm. They do not know the policies and procedures to follow in the event of concerns about a child's welfare or how to respond to any concerns about another member of staff. This is also a breach of the Childcare Register.
- Staff do not adequately promote children's health. They do not collect all required information from parents regarding children's needs for medicines. This is also a breach of the Childcare Register.
- Children choose to spend time outdoors but there is little in the outdoor area to stimulate and engage those looking to play physical games.
- Some parents do not feel well informed about how their children have spent their day.
- Self-evaluation does not identify breaches in requirements or key areas for improvement.

It has the following strengths

- Staff take children on a wide variety of educational and fun outings that promote their understanding of the world. For example, they attend museums, boat rides, the theatre and parks, and enjoy activities in woodlands.
- Staff use risk assessments effectively to identify and remove any hazards. Staff are deployed well to ensure children are supervised effectively in the setting which is shared with others.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The trained lead safeguarding practitioner fully understands their role. However, the provider has not ensured that all staff have sufficient knowledge of safeguarding. Individual staff do not know how to recognise the signs and symptoms that may indicate a cause for concern about a child's welfare. They are not confident in the reporting procedure to follow should any concerns arise about a child or a member of staff. Arrangements for administering medicines are not effective. Staff do not gain accurate information from parents about the needs of children who administer their own medication. The manager offers some useful support to staff by identifying strengths and weaknesses in their practice and, for example, gives them ideas and training on how they can improve. This helps to improve children's play experiences. However, not all weaknesses in staff's safeguarding knowledge are identified through self-evaluation. Overall, parents are happy with the club and like the variety of outings offered. Some parents feel that they do not get sufficient day-to-day information about how the club supports their children, including the activities in which children take part.

Quality of teaching, learning and assessment requires improvement

Children generally have fun at the club. They make good use of the well-resourced indoor area. However, there is less for children to do outside and, at times, they are bored and disruptive. Staff link activities to cultural celebrations to help children develop their knowledge of the wider world. For example, to mark Chinese New Year, children decorated dragon masks and lanterns. Children learn to socialise and develop their creative skills through activities, such as making bracelets or playing with construction toys.

Personal development, behaviour and welfare are inadequate

The lack of safeguarding knowledge among the staff team means children's welfare is not adequately promoted. Staff provide valuable support for children to learn how to manage risks in their physical environment. Children use the large playground to practise how to walk safely on the road, supported by staff. For example, children wear high-visibility jackets and walk safely in pairs in a line to their destination. Children form positive relationships with staff. Staff praise children and help them build their self-esteem. Overall, children are independent and confident in their play. Staff provide children with healthy meals and remind them about good hygiene routines. Children have a good understanding of healthy lifestyles.
