Summary of key findings for parents

This provision is good

- Managers and staff are committed to providing children with good quality care and education. They are ambitious for children to succeed and offer them a wide range of exciting activities. Children make good progress from their initial starting points.
- Managers and staff are good role models. Children develop the ability to manage their own feelings well, and grow in confidence. They are tolerant, enjoy working together, behave well and learn to share.
- Managers and staff build positive relationships with parents. Parents give very positive feedback and value the frequent opportunities to share information about their children, and the guidance they receive about supporting children's learning at home.
- The management team has made very positive changes since the previous inspection. Areas identified for improvement have been successfully addressed and self-evaluation is used to help continuously drive improvements and raise outcomes for children.

It is not yet outstanding because:

- Managers and staff do not consistently take every opportunity to challenge and extend children's mathematical learning to the highest levels.
- Managers and staff sometimes carry out simple tasks for children that they could undertake for themselves.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- maximise the opportunities to promote children's mathematical learning and understanding of mathematical concepts during everyday activities
- develop children's independence even further by supporting them to carry out some age-appropriate tasks for themselves.

Inspection activities

- The inspector observed the quality of teaching in all areas of the nursery and assessed the impact this has on children's learning.
- The inspector sampled a range of documentation, including attendance records, staff suitability checks, the self-assessment information, children's observation, assessment and planning records, and documentation linked to managing children's progress.
- The inspector held discussions with the management team and spoke with children and staff at appropriate times throughout the inspection.
- The inspector took into account the views of parents and carers spoken to on the day of the inspection and from written information.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. Managers and staff understand their role in safeguarding children and how to respond to any concerns they may have about a child's welfare. Furthermore, robust recruitment procedures help to ensure the suitability of all adults working within the nursery. Managers support staff well. For example, they regularly observe their practice and give targeted feedback to improve teaching. Managers effectively monitor and track the progress of all children. Any gaps in learning are quickly identified and appropriate action is taken. Managers and staff are well qualified and committed to improving their teaching skills. For example, they attend a wide range of training opportunities, which helps support them to deliver good quality learning experiences. Managers have established good links with the local school and other professionals, which helps ensure continuity of learning and care.

Quality of teaching, learning and assessment is good

Managers and staff undertake accurate observations and assessments of children's learning to help plan for the next stage in their development. Managers and staff promote children's communication and language skills well. For example, they talk to children about their activities and extend vocabulary as they introduce words such as 'camouflage' and 'habitat'. In addition, they sensitively communicate with younger children and respond to their vocalisations. Managers and staff successfully promote children's literacy skills. For example, children look at books independently, recall favourite stories and enjoy activities that help them to link letters to sounds. Children have many opportunities to be creative and to use their imagination. For example, they mix paints together to create new colours and use their imagination as they drive trains.

Personal development, behaviour and welfare are good

Children's social and emotional well-being is promoted well. For example, managers and staff support children to settle in quickly and build strong bonds with their key person. Children follow good hygiene routines. Children enjoy playing actively outdoors and have plenty of opportunities for fresh air and exercise. Managers and staff teach children about the wider world. For example, they embrace diversity, celebrate differences and similarities and help children to develop a strong sense of their own identity.

Outcomes for children are good

All children make good progress in readiness for school. They concentrate on their chosen activities and demonstrate a positive approach to learning. Children's development of literacy is encouraged. For example, they write their names or make individual marks on their work. Children engage all of their senses as they play. For example, they explore different textures and discuss smells that they like and dislike.

Zebedees Day Nursery registered in 2001 and is located close to St Andrews Park, Bristol. The nursery employs 16 members of childcare staff. Of these, 11 hold appropriate early years qualifications at level 3 or above. The manager holds an early years management qualification at level 7. The nursery opens from Monday to Friday, all year round. Sessions are from 8am until 6pm. The nursery provides funded early education for children aged three and four years.
