## Summary of key findings for parents

## The provision does not meet requirements

- The provider has not informed Ofsted of new committee members. This is also breach of the Childcare Register requirements. This has no impact on children's welfare because all committee members have full suitability checks.
- All staff have a secure knowledge of how to safeguard children. The provider knows how to carry out risk assessments of the premises and minimise risks to children.
- The provider knows the importance of monitoring staff's practice and evaluating the provision, to identify and address areas for development.
- The provider and staff know how to plan to meet children's needs and to encourage them to participate in new experiences. They understand the importance of working in partnership with others to meet children's individual needs.
- The provider understands the importance of promoting children's emotional and physical well-being. Staff know how to establish positive relationships, make children feel welcome and manage their behaviour appropriately.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Bude After School Club registered in 1997. It has been operating from its current location since 2006. This is one of two registrations held by the after school club. It operates from the school hall at Bude Infants' School when the church hall, under the separate registration, is unavailable. It offers care during some Easter and summer holidays, from 8am to 6pm Monday to Friday. The club employs six staff to work with the children. Of these, four hold an appropriate qualification to level 3. At inspection, there were no children present under this registration.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
