Summary of key findings for parents

This provision is outstanding

- The extremely knowledgeable and well-qualified childminder plans rich, imaginative play experiences for children, both indoors and outdoors. Children are highly motivated, eager to explore and maintain their focus during activities over a sustained period of time.
- The childminder has an excellent understanding of how children learn and develop. She uses every available opportunity to enhance children's language, social and physical skills through play-based activities. This helps to prepare children superbly for future learning.
- The childminder has developed excellent partnerships with parents and others involved in children's education and care. She uses a range of highly successful strategies to actively engage parents in promoting and extending their children's learning at home.
- The childminder is fully committed to her own personal and professional development. Self-evaluation is highly effective in identifying and addressing areas for improvement.
- Children are immensely well settled and confident within the setting because the childminder has a precise and sensitive understanding of their needs. They show a strong sense of security and enjoy warm, positive relationships with the childminder.
- The childminder puts children's safety and well-being at the centre of everything she does. Risk assessment is thorough and contributes strongly towards their safety and well-being, which are promoted to a very high standard.
- The childminder provides a very welcoming and stimulating learning environment. She ensures this accurately reflects children's needs and interests, and successfully promotes their growing independence and enthusiasm for learning.

Inspection findings

Effectiveness of the leadership and management is outstanding

The arrangements for safeguarding are effective. The childminder's knowledge and understanding of safeguarding, and her practices designed to keep children safe are excellent. The highly dedicated, inspirational childminder continues to provide the highest quality of care and learning experiences to children. She meticulously monitors the progress children make, to help her narrow any gaps in their learning. Excellent use is made of training, research and self-reflection to strengthen and enhance her provision. Since her last inspection, she has successfully completed an early years degree and gained Early Years Teacher status. She uses her knowledge and skills to continually improve her practice, and to maintain the exceptional standards of care and education she provides for children and their families.

Quality of teaching, learning and assessment is outstanding

Children receive exceptional support from the childminder. She is highly skilled in teaching children to learn through play. The childminder has transformed her garden into a unique, outdoor learning space. Children thoroughly enjoy playing in the mud kitchen and taking part in sensory play as they scoop sand and sprigs of lavender into containers. The childminder skilfully teaches children how to use real tools safely. For example, she encourages them to use two hands and to persevere, in order to saw wood. The childminder uses various strategies, including sign language to help children to be enthusiastic, articulate speakers. Older children use a wide range of vocabulary to describe what they are doing, recall events and solve problems. The childminder gives children an excellent foundation in early literacy and mathematics. Children recognise their name, identify letters and sounds, and practise emerging writing skills. They confidently use numbers for counting and comparing, and they recognise complex shapes. The childminder has identified the potential to extend this to include 3D shapes. The childminder knows exactly how well children are progressing and which aspects of their development to focus on next. She regularly exchanges comprehensive information with parents about their children's abilities and learning priorities.

Personal development, behaviour and welfare are outstanding

The childminder provides an environment where children flourish, both physically and emotionally. Children's behaviour is exemplary. The childminder is a superb role model and successfully encourages children to share, take turns and play together cooperatively. Older children often help the younger children with everyday tasks, and the childminder promptly acknowledges their efforts and achievements. The childminder conscientiously meets children's care, health and dietary needs. She provides plenty of opportunities to be physically active and expertly helps them to become increasingly independent in seeing to their personal care.

Outcomes for children are outstanding

Children make outstanding progress in relation to their starting points. They are highly confident and very eager to learn. This contributes towards them being exceptionally well prepared for the next stage in their learning and their move on to school.
