Summary of key findings for parents

The provision meets requirements

- The childminder has appropriate policies and procedures to safeguard children. She is aware of her responsibility to keep children and her environment safe and knows the process to follow if she becomes concerned about a child's welfare.
- The childminder knows how to teach children about healthy lifestyles, for example, by promoting healthy eating and providing regular opportunities for physical exercise.
- The childminder understands the importance of evaluating her service and continually improving her knowledge. She knows how to involve parents and children in this process to help her reflect and identify areas for improvement.
- The childminder understands the types of activities to plan for all children so that they remain continually motivated and engaged while they are in her care.
- The childminder recognises the importance of working with parents to promote continuity in care and teaching and to prepare children for changes, such as moving to school.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder to explore her understanding of the requirements for the Early Years Foundation Stage.
- The inspector viewed a sample of documentation the childminder intends to use, such as policies and procedures, attendance records and records for administering medicine.
- The inspector spoke with the childminder about how she evaluates and improves her service.
- The inspector was given a tour of the premises.

The childminder registered in 1996. She is based in Hornchurch, within the London Borough of Havering. The childminder operates from Monday to Friday, 8am to 9am and 3pm to 6pm, during term time. On the day of inspection there were no early years children on roll.
