Summary of key findings for parents

The provision does not meet requirements

- The childminder has failed to notify Ofsted of people living in the household over the age of 16 years. She has not provided the required information to enable suitability checks to be carried out.
- The childminder does not have the required public liability insurance in place.
- The childminder has a poor knowledge of the statutory requirements of the Early Years Foundation Stage and does not meet her legal responsibilities.
- The childminder understands how to promote children's development across the different areas of learning. She knows how to tailor activities to suit individual children's needs and describes how she would challenge them to meet their next steps in learning.
- The childminder understands the importance of promoting children's health. She has systems in place to ensure that children eat healthily, exercise daily and learn about good hygiene practices.
- The childminder understands the benefits of working with parents and other providers to ensure children's individual needs are consistently met.
- The childminder demonstrates a suitable understanding of how to manage children's behaviour. She knows how to encourage children to share and take turns. She understands the importance of acknowledging their achievements.
- The childminder uses her self-evaluation process to identify where she can increase her skills and knowledge and improve outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage and the Childcare Register the provider must:

The childminder was registered in 2011 and lives in Low Moor, West Yorkshire. She operates all year round from 7.30am to 5.30pm, Monday to Friday, except for bank holidays and family holidays.
