Summary of key findings for parents

The provision meets requirements

- The childminder understands the learning and development requirements. She keeps up-to-date with changes. She knows how to provide children with learning experiences to meet their differing backgrounds, ages and abilities.
- The childminder is aware of her role and responsibility to maintain children's good health, to promote their welfare and to keep them safe. She understands how to identify any concerns relating to a child's physical or emotional welfare, and the need to report these to the relevant agencies.
- The childminder is motivated to extend her professional development. She is aware of the need to evaluate her service.
- The childminder understands the need to promote children's personal development. She is aware of how to manage children's behaviour and of the need to teach children to respect others from other backgrounds, or who have different abilities.
- The childminder recognises the importance of establishing professional relationships with parents to identify children's needs, and to share information and children's progress.
- The childminder knows the need to observe and assess children's abilities when they start with her, and how to use this information to help to prepare children for their eventual school.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder to assess her understanding of the requirements for the Early Years Foundation Stage.
- The inspector looked at areas of the childminder's house intended for the use of children.
- The inspector discussed with the childminder how she intends to maintain required documentation to promote children's safety and welfare at all times.

The childminder registered in 1998. She lives in Upminster in the London Borough of Havering. She is available to care for children from on weekdays throughout the year. At the time of the inspection, there were no children on roll.
