Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The provider has not informed Ofsted of changes to committee members as required.
- The provider does not ensure that all records are easily accessible and available for inspection as required.
- Staff supervision is not sufficiently robust. These sessions are not used effectively to provide support for staff, monitor and strengthen their practice, identify their training needs and improve their performance.

It has the following strengths

- The activities provided are based on children's interests. The environment is well planned to encourage children to explore freely and make independent choices. After school, all children arrive with enthusiasm and are eager to participate in many exciting experiences.
- Strong partnerships with the school have a positive impact on children's care and well-being. Staff exchange regular information with school teachers and follow school themes when planning activities. This helps to ensure continuity between the school and the club.
- Children are supported by welcoming and caring staff. Children demonstrate that they feel emotionally secure and strong relationships exist between staff and all children. Staff are positive role models who actively promote children's good behaviour.

What the setting needs to do to improve further

Inspection findings

Effectiveness of the leadership and management requires improvement

The arrangements for safeguarding are effective. The provider and all staff understand their role and responsibility to keep children safe and are aware of the correct procedures to follow, should they have a concern about children's welfare. However, the provider is not fully aware of the welfare requirements. She has not informed Ofsted of changes to committee members. This has minimal impact on children as the new committee member has had all suitability checks completed. Furthermore, the provider has not ensured that all required documentation is available for inspection. Staff are well qualified and experienced. However, they are not supported through effective supervision meetings, as a way of improving their performance. Self-evaluation is used well and includes the views of staff, children and parents. There are clear action plans in place and the provider and staff strive for continual improvement. Parents comment that they are extremely happy with the club. They are complimentary about the supportive and friendly staff and good quality experiences that their children are provided with.

Quality of teaching, learning and assessment is good

Experienced and highly qualified staff use their knowledge well to provide all children, including disabled children and those with special educational needs, with good quality experiences and activities. Staff are skilled at extending children's imaginative play and cooperation. Children participate in pretend play using a doll's house and figures. Older and younger children are encouraged to play card games together and they take turns to build with bricks. Children's creativity is promoted well. Staff provide an interesting range of materials for children to make individual Mother's Day cards. Children happily choose from the resources available as staff talk to them about Mother's Day. They ask purposeful questions to engage children in conversation. This helps them to develop their speaking and listening skills. Staff provide activities which complement what children learn in school. This contributes towards them being well prepared for their next stages in learning. Staff provide good opportunities for even young children to practise their writing skills.

Personal development, behaviour and welfare are good

Staff place great importance on supporting children's independence and confidence. Young children have a key person and are collected from their classrooms. This helps them to move smoothly from school into the club. Staff are sensitive to all children's individual needs. They provide quiet activities for children who choose to rest or relax after their day at school. Staff help to promote children's physical well-being. They actively encourage positive hygiene routines. Regular outdoor play activities and a well balanced and varied diet contributes towards children's good health. Snack time is a social occasion as staff and children sit and eat together. Staff encourage children to use good manners and they teach them to value and respect themselves and others.

St Marys After School Club has been registered since September 2000. The club opens each weekday from 7.30am to 9am and 3.15pm to 6pm, term time only. The club currently supports disabled children and those with special educational needs. The club employs nine members of staff. Five members of staff hold appropriate early years qualifications at level 3 and one member of staff holds a qualification at level 2.
