Summary of key findings for parents

This provision is good

- The experienced management team is passionate about providing high quality provision for children. Managers have established effective systems to involve staff, parents and children in the evaluation of the provision. They are aware of areas for further development and plan actions to drive continuous improvement.
- Staff assess what children know, understand and can do effectively and plan activities based on the children's interests. Staff are enthusiastic and children are motivated and engaged in their learning.
- Staff establish good partnerships with parents. They share information about children's progress and suggest ways that parents can support their children's learning at home.
- Staff are kind and supportive, and they build strong relationships with children, who enjoy the time they spend in their care. Children who are new to the centre settle quickly.
- Staff identify children who need additional support accurately and promptly. They work closely with other professionals, such as speech therapists, to ensure that no child falls behind and that all children make good progress relative to their starting points.

It is not yet outstanding because:

- Occasionally, staff do not give children sufficient time to respond to questions to strengthen their language and thinking skills further.
- Staff do not always use opportunities to raise the level of challenge for older children.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- give children more time to answer questions to strengthen their language and thinking skills further
- strengthen the good teaching to make full use of opportunities that arise to increase the level of challenge for older children to extend their learning.

Inspection activities

- The inspector spoke to managers, members of staff and children at appropriate times during the inspection.
- The inspector observed the quality of teaching during activities and assessed the impact this had on children's learning.
- The inspector carried out a joint observation with the manager.
- The inspector took account of the views of parents spoken to during the inspection.
- The inspector looked at children's learning records and planning documentation. She checked evidence of the suitability and qualifications of staff working with the children and looked at policies and procedures.

Inspection findings

Effectiveness of the leadership and management is good

Managers have established robust recruitment procedures to ensure that all staff are suitable to work with children. Regular training, supervision sessions and observations of teaching help to ensure that staff are fully supported in all aspects of their professional development. Managers monitor the progress of individual children as well as groups of children, and ensure that interventions are put in place for those who need additional support. For example, they have introduced additional resources and activities to further improve boys' mathematical skills and close any gaps in their learning. Safeguarding is effective. All staff understand their role and responsibility in safeguarding children and know what to do if they have any concerns about a child's welfare.

Quality of teaching, learning and assessment is good

Teaching is strong and this has a positive impact on children's development. Staff have a good understanding of how children learn. They provide a welcoming environment with a wide range of easily accessible resources and interesting activities indoors and outdoors. Children confidently move around choosing toys they wish to play with and activities they wish to join. Younger children enjoy a variety of experiences exploring different materials and textures. For example, they sit in a box of shredded paper or explore what happens when they mix sand with shaving foam. Older children enjoy listening to stories and singing their favourite songs. This helps to develop their language skills and vocabulary.

Personal development, behaviour and welfare are good

Staff are good role models and set clear boundaries so children's behaviour is very good. They offer praise and encouragement, where appropriate, to build children's self-esteem. Staff support children's understanding of safety well. For example, they explained to children what might happen if water they had spilt on the floor was not cleaned up. Children learn about healthy eating as they choose from a variety of fruits at snack time. Children enjoy physical exercise and develop coordination skills, for example, as they balance outside using blocks and tyres. Staff promote children's understanding of other cultures, helping them learn to respect and value other people. Children leaving to go to school and other settings are emotionally prepared for change. For example, staff organise a graduation ceremony to celebrate their achievements with family and friends.

Outcomes for children are good

All children learn key skills which they need for their next stage of learning. Younger children develop good early communication and physical skills. Older children are independent, motivated and confident learners with a range of skills that prepare them well for their move to school.

Rotherhithe Early Years and Parents' Centre opened in 1997. It is accommodated in a self-contained unit linked to Rotherhithe Primary School in Southwark. Overseen by the governing body of Rotherhithe School, the day care is open from Monday to Friday from 8am until 6pm, term time only. There are 13 staff working with the children. The provider is in receipt of funding to provide free early education for children aged two, three and four years. All staff have appropriate early years qualifications and one has Early Years Professional Status.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
