Summary of key findings for parents

This provision is good

- The manager is effective in her leadership. She ensures that all documentation is well maintained, up to date and easily accessible. She monitors children's progress closely, enabling her to promote ongoing development in teaching and learning.
- Staff provide a range of interesting play activities, all of which are set out attractively to encourage children to explore. Staff are particularly good at interacting appropriately with children, helping them to extend their learning through their own interests.
- Staff regularly attend training courses to further their own professional development. This helps them to broaden their approach and contributes positively to the continuing improvements in children's achievements across the learning areas.
- The manager liaises with other professionals to establish better ways of working. For example, staff and parents now benefit from the use of an electronic system of assessment, and children benefit from the provision of a new outdoor play area.
- Staff promote a relaxed working environment and calm atmosphere. As a result, all children make good progress, become confident in making choices independently and build good relationships with others in the group.

It is not yet outstanding because:

Children do not always have enough opportunity to learn about the natural environment, for example, through the exploration of natural materials and living things indoors and outdoors.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

provide a wider variety of opportunities for children to learn more about the natural environment in both indoor and outdoor activities.

- The inspector observed children taking part in a variety of indoor and outdoor activities.
- The inspector spoke with members of staff and parents, and interviewed the manager.
- The inspector sampled the documentation, in particular those documents relating to children's progress and safeguarding.

Inspection findings

Effectiveness of the leadership and management is good

The manager has a good understanding of the statutory requirements. She has introduced effective systems for assessing the quality of the educational programme and highlighting aspects that require improvement. This has led to a recent focus on improving children's skills in mathematics, language and literacy. Safeguarding is effective. Staff are vigilant and keep up to date with relevant issues. The manager makes available information about child protection for staff and parents. Staff actively involve parents in supporting children in their learning at home. Staff are developing links with schools in the local area and this is particularly helpful for children when moving on.

Quality of teaching, learning and assessment is good

Staff use resources effectively to create a stimulating play environment. Children are keen to take part in activities. Staff are adept at helping children to be active and independent learners. For example, during play they follow children's ideas but also make their own suggestions as to how to use resources. In this way, children learn techniques and acquire skills. When engaging children in conversation, staff encourage children to think and to use language in different ways to express themselves. Staff take opportunities to increase children's awareness of number, shape and pattern. Staff make focused and meaningful observations and use these to move children on in their individual learning, according to their particular needs.

Personal development, behaviour and welfare are good

Staff are attentive to children's care needs and ensure good hygiene in their daily routines. They promote children's health effectively by offering attractive fresh fruits for snack and daily opportunities for outdoor play. Children are well settled and concentrate hard on their chosen tasks. Staff manage children's behaviour in appropriate ways, taking time to talk with children individually when issues arise. Children behave responsibly and in ways that are safe. There are good opportunities for children to learn more about different cultures. For instance, children learnt how to use chopsticks and enjoyed tasting Chinese foods. Staff are mindful of the differing needs of disabled children and those who have special educational needs. They have recently made changes to the indoor environment to create space and improve accessibility to activities.

Outcomes for children are good

Children enjoy opportunities to express their own ideas creatively when making pictures and models. They learn to enjoy books and like to settle down in the book corner with an adult. Staff emphasise the teaching of key skills that are useful for the future. Consequently, all children make good progress given their individual starting points. Children show a good attitude towards learning and are well prepared for school.

Tiny Tots Pre-School Nursery registered in 2013 and is privately owned. It operates from a church hall in Enfield, in the London Borough of Enfield. The pre-school is open every weekday from 9.00am until 12.00 noon, and on Tuesday and Thursday until 3.00pm, during term time. The pre-school receives funding for the provision of free early years education to children aged two, three and four years. The pre-school supports disabled children, those who have special educational needs and those who are learning to speak English as an additional language. The pre-school employs six staff, all of whom hold relevant early years qualifications. The pre-school manager holds both Qualified Teacher Status and Early Years Practitioner Status.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
