Summary of key findings for parents

This provision is outstanding

- Children thoroughly enjoy their time with the childminder. They very confidently explore the toys and investigate their surroundings. Children benefit greatly from the individual attention that they receive, which helps them to feel very safe and secure. Children quickly develop extremely positive attachments to the childminder.
- The childminder makes highly effective use of her observations to monitor children's achievements and plan very stimulating activities that help children make excellent progress from their starting points.
- The childminder provides very exciting activities, and she interacts with great skill, promoting children's extremely strong communication and language skills.
- The childminder uses self-evaluation exceptionally well to help her make improvements to her service. She identifies detailed and clear priorities to ensure that she maintains her outstanding practice.
- The outdoor provision is a particular strength, with very exciting areas which challenge children to keep fit and effectively contribute to their health and welfare.
- Excellent partnership with parents ensures that the childminder finds out detailed information about the children's individual care and learning needs, enabling her to support them extremely well. She shares information about what children learn each day with parents, so they can continue the learning at home.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder has a very secure understanding of children's needs and abilities, and uses her excellent teaching to provide very focused and effective activities. She regularly checks children's progress to identify and close any emerging gaps. The childminder puts her childcare qualification to great effect to create a highly exciting learning environment, and to enthuse and engage children. She makes excellent use of training, for example, in children's language, to develop how she communicates and uses resources to extend children's discussions and conversational skills. The childminder has an extremely clear understanding of keeping children safe and what to do if she is concerned about children's welfare. Safeguarding is effective.

Quality of teaching, learning and assessment is outstanding

Since the last inspection, the childminder has improved children's learning experiences exceptionally well by completing an Early Learning Audit as part of her training. This has helped her to make very positive changes that enable children to progress at a fast rate. For example, there is a very sharp focus on letting children use 'choice boards' to identify what they want do next. This very successfully encourages children to make decisions for themselves from the exciting range of activities. For example, children confidently chose a card for painting and gave this to the childminder. She quickly found the colours that they knew, and one new unknown colour. This resulted in very high quality learning in a relaxed and enjoyable way. The childminder's excellent interaction develops children's vocabulary and communication skills very well. The childminder has very high expectations of what children can achieve. She plans excellent individual tasks for each child based on her own detailed observations of their play, although there are fewer opportunities for children to use technology as they learn.

Personal development, behaviour and welfare are outstanding

Children are extremely happy and thoroughly enjoy their time with the childminder. They quickly learn about the childminder's routines and expectations, helping them to investigate safely with great enthusiasm. Children are exceptionally well behaved. They benefit from very high standards of care and hygiene. Children show extremely strong social skills and confidence as they chatter and respond to questions.

Outcomes for children are outstanding

Children gain excellent skills for future learning and moving on to school. They are extremely confident and independent learners who are highly inquisitive, with a very positive attitude to trying new things. They develop excellent communication and literacy skills, confidently expressing their needs, thoughts and ideas. Children learn to write their names and use mathematical skills to count and solve problems.
