Summary of key findings for parents

This provision is good

- The managers work well together to provide good quality care and education for children. They ensure that the provision is safe, welcoming and inviting. Children are excited to take part in activities and keen to choose which resources to use.
- The well-qualified staff guide children's learning well. They patiently teach children new skills and extend their learning. For example they ask thoughtful questions and comment on what children are doing. Children, including those who are learning English as an additional language, make good progress.
- Children are happy and settled. The managers organise staff and routines effectively to promote children's sense of well-being and security.
- Children behave well for their ages and handle resources and equipment with great care. They are developing into independent and thoughtful young people.
- Staff work well with parents to meet children's needs. They keep parents fully informed about their children's progress and help them to continue children's learning at home.

It is not yet outstanding because:

- Staff do not always fully consider the learning needs of some children taking part in everyday activities. Children occasionally lose interest and become distracted; for example, during some singing and story times.
- Staff do not always make the best use of opportunities to encourage children to explore technology, to fully promote their understanding of the world around them.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- strengthen the organisation of some everyday activities, to fully engage all children and to meet their individual learning needs
- extend opportunities for children to explore everyday technology, to strengthen their understanding of how things work.

Inspection activities

- The inspector observed children and staff, indoors and outdoors.
- The inspector carried out a joint observation with the manager.
- The inspector took account of the parents' views.
- The inspector spoke with staff about their understanding of safeguarding, child protection and first aid.
- The inspector sampled documentation, including children's records, the provider's policies and staff's qualifications.

Inspection findings

Effectiveness of the leadership and management is good

Managers regularly review the overall quality of the provision and the progress children make. They involve parents and staff in this process. They plan and implement identified areas for improvement; for example, they have improved the range of activities and resources for children outdoors. Managers effectively identify where children are not making expected progress and work with other professionals to help these children catch up with their peers. They encourage staff to attend additional training and develop their teaching skills, and meet regularly with each member of staff to discuss their performance. Safeguarding is effective. Managers implement robust procedures to ensure staff are suitable to work with children. All staff understand their responsibility to safeguard children and know what to do if they are concerned about a child's welfare.

Quality of teaching, learning and assessment is good

Staff use their knowledge of how children learn to provide a broad range of experiences that help children to make good progress. Staff are especially effective in helping children to develop their physical and mathematical skills. For example, children enjoy taking part in a wide range of sorting, counting, threading and pouring activities. Staff support all children's developing language well. They successfully help children who are learning English as an additional language to develop their understanding and use of the English language. Children are learning about the world in which they live. Staff ensure that resources reflect children's unique experiences and backgrounds, and they celebrate a wide range of festivals with all children, to help them learn about diversity.

Personal development, behaviour and welfare are good

Staff promote children's physical well-being effectively. They provide healthy snacks and offer parents suggestions for nutritious packed meals when children stay for lunch. Children enjoy daily opportunities to play in the fresh air and know that they can ask for extra time outdoors, in addition to the times planned as part of the daily routines. Staff have improved arrangements for hand washing to further promote children's good health. Children are confident in meeting their own needs. For example, they choose when to have a snack and a drink, and clear away and wash up when they have finished. The managers organise the nursery so that children play and learn alongside familiar staff each day. Children are happy and comfortable in the calm, nurturing environment.

Outcomes for children are good

All children make good progress. They gain the skills needed for their future learning, including the move to school. For example, older children learn to write recognisable letters and develop a good understanding of shapes, sizes and numbers. Children know how to consider other children's needs and how to take care of their surroundings.

Children of the world Montessori School registered in 1999. It is situated in Windsor, Berkshire and is open from 9am to 3.30pm, Monday to Friday, term time only. The provider receives funding to provide free early years education to children aged two, three and four years. There are seven members of staff, all of whom hold relevant qualifications at level 3 or above. Staff follow the Montessori methods and philosophy.
