- The manager understands how to provide appropriate indoor and outdoor resources and activities for the children to enjoy and learn, and help them make progress.
- The manager knows how to manage children's behaviour in a suitable way so that they learn to behave well and respect others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. Barlby Play Centre registered in 2012. The provision is run by People Potential Possibilities. It operates from Barlby Primary School in Ladbroke Grove, in the Royal Borough of Kensington and Chelsea. It is open each weekday from 3.30pm to 6.00pm during term time only. The provider employs five members of staff; of whom, two are qualified at level 3 and three are unqualified. There were no early years children present at the time of the inspection.
