Summary of key findings for parents

This provision is good

- Staff plan exciting and purposeful activities which engage children and challenge their thinking very well. They notice and record children's particular interests and use these to extend their learning. They establish clear starting points for children's learning. They review children's progress regularly and close any gaps in their learning quickly.
- Staff know children's stages of development through their observations and information obtained from parents. They evaluate planning, teaching and children's progress very well. They meet children's individual needs and work very effectively with parents to support the next steps in their learning. Children are very well prepared for the next stage in their learning and for school.
- Children settle very well at the nursery and form close relationships with staff and each other. They are emotionally secure in the homely environment and staff meet their individual needs. Children's behaviour and manners are excellent. Children's health and well-being are given high priority.
- There is thorough and effective monitoring of all aspects of the provision and children's progress. Strong teamwork means there is continuous improvement in children's learning experiences.

It is not yet outstanding because:

- Self-evaluation is not yet sharply focused enough to identify more specific areas for continuous improvement in the provision as a whole.
- Partnership working with other providers is not yet sufficiently developed to raise the expectations of children's achievements even further.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- develop a more focused vision for self-evaluation that increases the potential to achieve excellent outcomes for children
- strengthen partnership working with other early years providers, sharing best practice that helps raise expectations for children's outcomes even further.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors and assessed the impact this has on children's learning.
- The inspector completed a joint observation with the nursery manager.
- The inspector held a meeting with the nursery manager and provider. She looked at relevant documentation, such as the nursery's self-evaluation and evidence of the suitability of staff working in the nursery.
- The inspector spoke to a small selection of parents during the inspection and took account of their views.

Inspection findings

Effectiveness of the leadership and management is good

Arrangements for safeguarding are effective. The management team ensures all staff have a secure understanding of the policies and procedures. Staff are vigilant in their supervision of children and in the implementation of all safeguarding procedures. The premises are secure and fire drills are practised monthly with staff and children. The new manager has made many improvements since she took over the post. Staff inductions are very thorough so that staff understand their roles and responsibilities. All staff are suitably checked before they start at the nursery. They are very well supported to continue their professional development. This helps to maintain the good quality of teaching and children's learning. The manager and the deputy manager observe staff practice and set targets for improvement. Staff evaluate and review their performance. This helps to improve their teaching and planning and children make good progress.

Quality of teaching, learning and assessment is good

The quality of teaching is consistently very good throughout the nursery. Staff stimulate children very well and maintain their interest in activities. Babies are happy and confident to explore their room and they examine an interesting range of toys with enthusiasm. They are extremely well stimulated and they enjoy repeating sounds and words with encouragement from staff. This helps to develop their language and understanding as they play. Toddlers love to look at books with staff. They name animals and are learning to identify colours. Staff help children to count during their play and through number songs. Pre-school children learn French and staff develop children's language and understanding very well through their skilful questioning. Children enjoy increasing their hand-to-eye coordination when they aim balls into buckets. Staff make learning fun and children thoroughly enjoy their time at this welcoming nursery.

Personal development, behaviour and welfare are good

The caring staff comfort children if they are upset, giving them cuddles and their comfort items. They obtain detailed information from parents about children's routines, diet and needs, ensuring they are secure and well protected. Staff praise children frequently and value their opinions, helping them to gain confidence and good self-esteem. Children enjoy nutritious, home-cooked food and are encouraged to drink water regularly throughout the day. They are taught to share and take turns as they play. Staff teach children to have respect for each other's views and cultures and these are celebrated at nursery. Children's dietary requirements are adhered to and they enjoy outdoor play and exercise. Children's moves to new rooms and to school are managed extremely well. These are tailored to meet children's individual needs and parents are involved in the process.

Outcomes for children are good

All children make good progress from their starting points. They are taught valuable social skills and to be independent in their care routines. They develop early literacy and mathematical skills in preparation for future learning.

Monkey Puzzle Day Nursery was registered in 2015. The nursery employs 11 members of childcare staff, 10 of whom hold appropriate early years qualifications at level 2, 3 or 5. The nursery opens from Monday to Friday, all year round, except for a week at Christmas. Sessions are from 7.30am until 6.30pm. The nursery provides funded early education for two-, three- and four-year-old children.
