Summary of key findings for parents

The provision meets requirements

- The management team and staff have a clear understanding of how to protect children from harm. This includes responding to any concerns about children's welfare, ensuring the suitability of staff and checking the environment is safe for children to use.
- The management team recognise the importance of working in partnership with parents, to share information about children and support continuity of care.
- Staff know how to provide activities that promote children's independence within their personal care routines and a healthy lifestyle.
- Management understand how to monitor and supervise staff to ensure they receive suitable support and training to enhance their personal development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector spoke to the manager and staff to determine their knowledge of the Early Years Foundations Stage requirements.

Fun Factory out-of-school club registered in 2006. It operates from Hampton Hill Junior School in Hampton, in the Borough of Richmond. It operates Monday to Friday, from 3.30pm and 6pm, term time only. There are six members of staff employed to work with children; of these, one holds a childcare qualification at level 6 and one holds a qualification at level 3. There were no children in the early years age range present at the time of the inspection.
