Summary of key findings for parents

This provision is good

- The childminder has a good knowledge of how children learn and develop. She oversees planning and uses information gathered to plan for children's individual needs.
- The childminder provides a welcoming, homely environment. Children have close relationships with the childminder and her assistant, which supports their learning and well-being. Children make good progress.
- Children enjoy learning about the world around them and their local community. For example, they regularly go on outings and attend community groups.
- The childminder and her assistant are good role models. They promote good manners and having respect for each other. Children benefit from constant praise and encouragement.
- The childminder regularly carries out risk assessments to ensure that children are safe to explore the environment, both indoors and outside.

It is not yet outstanding because:

- Overall, partnerships with parents are successful; however, the childminder does not always make full use of settling-in times to gain detailed information from parents about children's starting points, to help her to plan more effectively from the start.
- The childminder does not always explore fully the views of parents and children when evaluating the quality of her provision, to help her identify areas for further development.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- explore ways to gather more information from parents, particularly to help identify children's initial starting points more clearly
- develop further self-evaluation processes to reflect the views of parents and children to build on the already good quality of the provision for children.

Inspection activities

- The inspector looked at all parts of the childminder's home that are used by children.
- The inspector observed teaching practices and conducted a joint observation with the childminder.
- The inspector held discussions with the childminder, her assistant and the children during the inspection.
- The inspector looked at documents available, including policies and procedures, suitability checks and children's record books.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder and her assistant have a thorough understanding of their responsibility to keep children safe. The childminder maintains a good relationship with parents; she shares her policies and procedures and regularly updates them with information about their children's learning. The childminder oversees all planning to ensure a broad range of interesting and demanding experiences are available to help children make good progress. She ensures that the work of her assistant is strong. She and her assistant are good role models and children behave well.

Quality of teaching, learning and assessment is good

The childminder has a good understanding of how children learn. She regularly observes children in their play and assesses their development to plan for their next steps in learning. Planning is flexible as the childminder and her assistant have a child-centred approach. For example, children can choose their play from a wide range of toys and resources. The stimulating environment is provided around the individual interests of the children. Children are not distracted easily and able to concentrate on activities for long periods of time. For example, children enjoy planting seeds and learning how seeds grow, they are fully focused and eagerly learn about the natural environment and how it is home to living creatures. The childminder and her assistant support children's language well. They skilfully introduce new words in their play, which children sound out and repeat. Children enjoy sharing books and familiar rhymes, which supports their early reading skills.

Personal development, behaviour and welfare are good

Children benefit from close and warm relationships with the adults and each other. The childminder provides a safe and secure environment for children to explore. Children learn to share, take turns and be kind to each other. The childminder promotes good hygiene practices. For example, children learn the importance of brushing their teeth and keeping their hands clean. Children benefit from healthy snacks and daily exercise. The childminder supports children to learn how to keep safe. For example, children share books about feelings, they talk about crossing the road safely and they regularly take part in emergency evacuation procedures.

Outcomes for children are good

The childminder supports children well to develop the skills they need for their next stages in learning and for school. Children are confident, independent learners and are working within the typical range of development for their ages.
