- The childminder knows all children exceptionally well and plans around their individual needs and interests. She understands precisely what children can already do and how to support them further with exciting and challenging next steps.
- Children are happy and confident, and settle exceptionally well. They thrive in the welcoming and inviting environment which the childminder provides.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder evaluates her practice extremely thoroughly and is highly committed to enhancing her skills even further to continue providing the highest quality care and learning to the children. She meticulously observes and tracks children's exceptional achievements and plans sharply focused next steps to make sure that there are no gaps in their learning. She shares this information seamlessly with parents to help them play a fully active role in their children's learning. Safeguarding is effective. The childminder has an exceptional understanding of her role and responsibility to safeguard children. She has an excellent awareness of possible indicators that may show a child is at risk and of the procedures to report any concerns.

Quality of teaching, learning and assessment is outstanding

Children benefit from a highly stimulating environment, rich in learning resources, which encourages their curiosity and motivation to learn. The childminder interacts exceptionally well with children and makes the best possible use of all possible learning opportunities to help them gain knowledge across all areas of learning. For example, through an exciting water play activity using sea creatures and glitter, the childminder skilfully supports young children to explore textures, learn new words, develop early counting skills and enrich their understanding of the world. The exceptionally well-resourced outdoor learning environment mirrors the exceptional experiences children have inside, as they explore the garden enthusiastically. For example, they enjoy using interesting role-play equipment to explore and mimic their first-hand life experiences.

Personal development, behaviour and welfare are outstanding

The childminder meets children's care needs exceedingly well. She interacts sensitively and all children feel safe and secure in this nurturing environment. The childminder takes full account of children's backgrounds and skilfully develops their awareness of different people and their own community. Children develop a wonderful sense of belonging. For example, they love to look at pictures of their own families on the wall and point out people close to them. The childminder places the upmost importance on children's understanding of living a healthy lifestyle and takes every opportunity to encourage children to gain independence skills. For example, young children help to cut their own fruit at snack time and the childminder talks about using tools, such as knives, safely.

Outcomes for children are outstanding

Children receive an exceptional early education. They are highly motivated and display a true thirst for learning. Children make rapid and sustained progress, and acquire excellent skills they need in preparation for future learning. Young children become skilled problem-solvers and relish sharing a range of books, particularly about animals they have seen.
