Summary of key findings for parents

This provision is inadequate

- The childminder does not have an effective knowledge of the signs and symptoms that may cause concern regarding a child's welfare. This compromises children's well-being and is also a breach of the Childcare Register.
- The childminder does not provide children with a sufficient range of toys and resources that they can access independently to engage their interest and challenge their learning.
- The childminder does not plan purposeful activities to support children's next steps in learning and promote their development. Children do not make the progress that they should.
- The childminder does not develop partnerships with other settings that children attend to support a more consistent approach to children's care and learning.
- The childminder does not always encourage children to be independent. She feeds children who are capable and old enough to feed themselves.
- The childminder does not have a robust self-evaluation process in place to aid her in identifying weaknesses in her practice, knowledge and provision. She does not seek the views of parents and children to shape her service.

It has the following strengths

■ The childminder provides a safe environment for children. She helps children learn to keep themselves safe, for example, keeping nearby when on outings.

What the setting needs to do to improve further

- make effective use of self-evaluation, including the use of the views of parents and children, to identify breaches in requirements and target areas for improvement in practice.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The childminder has a poor knowledge of the signs that may indicate a child is at risk, which does not promote children's welfare at all times. The childminder does not evaluate her practice and identify areas for development to highlight weaknesses in her provision and improve outcomes for children. She shares information with parents about what their children have been doing, although she does not offer parents or children the opportunity to share their views about the setting. The childminder does not provide adequate resources that are accessible for children to explore and use in their play. The childminder does not have effective partnerships with other early years settings that children attend to promote continuity in their care and learning.

Quality of teaching, learning and assessment is inadequate

The childminder does not use information from her observations of children's progress to plan suitable activities that promote their next steps in learning. She has weak teaching skills. For example, while children were completing number puzzles, the childminder missed opportunities to encourage the children to count and did not identify that they needed help to complete the jigsaw. The childminder promotes children's language and communication skills sufficiently. She supports children who are learning English as an additional language to develop their language skills adequately.

Personal development, behaviour and welfare are inadequate

The weaknesses in safeguarding compromise children's well-being. The childminder does not make toys and resources freely available to enable children to take the lead in their play and learning. She does not encourage children to develop independent skills, such as feeding themselves. The childminder teaches children to share and have respect for the environment. Children behave well. The childminder takes children to local parks and playgroups to meet and socialise with other children and take part in physical play.

Outcomes for children are inadequate

Children are not well prepared for school or the next stage of learning. They do not take part in stimulating and engaging activities that encourage them to explore and learn for themselves.
