# Summary of key findings for parents

## This provision is inadequate

- The suitability of staff working with children is not adequately verified. In addition, staff are not aware of the circumstances in which they may be disqualified from working with children.
- A member of staff who has a current paediatric first-aid certificate is not always available when children are on the premises or on outings.
- Staff do not identify and minimise all hazards. Children are not always kept within sight or hearing of staff. Not all staff are aware of the procedure to follow in the event of a child going missing from the premises or on outings.
- Drinking water is not always available to children.
- Ofsted was not notified about a significant event which was likely to affect the suitability of the provider.

#### It has the following strengths

- Children enjoy attending the club and taking part in the wide variety of activities on offer.
- Children have good opportunities to develop their communication and language skills. They talk confidently in small- and large-group discussions to express their thoughts, feelings and ideas.
- Staff exchange information with parents on an ongoing basis to support continuity in children's care and learning.

- The inspector accompanied staff and children on an outing.

- The inspector held meetings with the manager. She looked at relevant documentation, such as evidence of the suitability of staff and the policies and procedures. She looked at and discussed the club's self-evaluation and improvement plans.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is not effective. Systems to ensure that all staff are, and remain, suitable people to work with children are not robust enough. Staff are well qualified and support children well in their play. However, at times, there are no staff present who have a current paediatric first-aid certificate to provide first aid to children if needed. The provider does not ensure staff are clear about their roles and responsibilities to safeguard children. Some staff do not know what procedures they must follow in the event of a child going missing. The provider committed an offence when they did not notify Ofsted of a significant event in relation to a child going missing during a recent outing. Staff know about some child protection issues. They know the procedures they must follow if there are any concerns about a child's welfare. The provider evaluates the quality of the provision for children's play. She seeks and responds to the views of children and parents, resulting in children enjoying their time at the club.

#### Quality of teaching, learning and assessment is good

Staff provide a vast range of activities that complements children's learning at school. Children say they like attending and enjoy taking part in all activities. They enjoy initiating their own play and following their own interests using the stimulating range of resources on offer. Children take part in planning topics, such as aliens and space, which include fun days and lots of craft activities. Children go on outings to feed the ducks, see films at the local cinema and bowl at the bowling alley. Staff are playful and skilful in following and supporting children's play. They ensure activities are well matched to children's needs, including disabled children and those with special education needs. Staff encourage children to take the lead in their play and express their ideas, feeling and thoughts.

#### Personal development, behaviour and welfare are inadequate

Children's safety is compromised. Children are not within sight or hearing of staff when they leave the playroom to go to the toilet at the end of the corridor. Staff do not always fully recognise and take suitable action to minimise hazards to children as they arise in the setting or during outings. Nevertheless, staff are very effective in supporting children's emotional well-being. Children develop very positive relationships with staff. They are settled and happy. Children are polite and considerate to others. They develop friendships and play cooperatively together. They are eager to help and they listen to and follow some safety instructions, such as walking with a partner on outings. Children have time to take part in energetic play using the stimulating and challenging outdoor equipment. They enjoy a variety of healthy snacks and their individual dietary needs are fully met because staff work in partnership with parents to achieve this. However, children's good health is not fully supported when they go on outings because they do not have access to a drink if they become thirsty.

Goldilocks Before, After School and Holiday Care was registered in 2012. The club operates each weekday during most school holidays from 8am until 6pm. During term time, the club operates after school until 6pm. There are five members of staff who work directly with the children. Of these, four hold relevant qualifications in both the early years field and playwork practice. The club supports disabled children and those with special educational needs.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
