# Summary of key findings for parents

## This provision is good

- The management team is dedicated and hard working. Since the last inspection, they have worked hard to improve the overall quality of the club and all statutory requirements are now met.
- There are effective partnerships between the club and parents. Information is shared on a regular basis to promote continuity of care and learning.
- Staff respect children's ideas and opinions. Children are encouraged to make contributions to the planning of activities. They are eager to join in with a range of learning experiences and are motivated to follow their own interests.
- Staff are patient, they know how to build children's confidence. They use praise and encouragement so children who are less confident to have a go try things for themselves.
- Staff form strong relationships with children and welcome them warmly. Relationships between each child, their key person and other members of staff are very good. This encourages children to feel secure and grow in confidence. Children settle well and are happy in this welcoming and friendly environment.

# It is not yet outstanding because:

- Professional development opportunities focus on mandatory training rather than prioritising areas that will enhance staff's overall practice.
- Staff do not fully make the most of opportunities to exchange relevant information about children with the host school.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- develop staff's knowledge further and focus more precisely on continually improving key areas of practice
- strengthen the two-way flow of information with the school about individual children's needs.

## **Inspection activities**

- The inspector spoke to a small selection of parents during the inspection and took account of their views.
- The inspector observed the quality of teaching during activities indoors and outdoors and assessed the impact this has on children's learning. The inspector evaluated the range of activities on offer, in discussion with the club manager.
- The inspector spoke to members of staff and children at appropriate times throughout the inspection.
- The inspector held a meeting with the club manager. She looked at relevant documentation, such as the club's self-evaluation and evidence of the suitability of staff working in the club.

# **Inspection findings**

## Effectiveness of the leadership and management is good

Arrangements for safeguarding are effective. Staff attend training in child protection. They are knowledgeable about different forms of abuse and they know the procedures to follow if they have concerns about children. The provider follows safe recruitment and vetting procedures to help ensure all staff are suitable to care for children. The staff carry out thorough safety checks and ensure that potential hazards are promptly identified and effectively minimised. The management team demonstrates a strong drive and commitment to ensuring that a good standard of care is provided for children. The views of staff, parents and children are taken into account when evaluating the quality of the provision. Well-focused improvement plans are implemented to drive forward changes. Parents are very complimentary about the care their children receive. They feel that their children are happy and safe while they are at the club. Several parents comment that their children are reluctant to leave when they arrive to take them home.

## Quality of teaching, learning and assessment is good

Staff have a good knowledge and understanding of how to complement children's learning through play. Children develop their creative and imaginative skills as they explore a range of creative resources and enjoy role play. There is much laughter and great teamwork between children as they create pizza from play dough and happily discuss their favourite toppings. Children develop a growing awareness of information technology, for example, by using applications on a computer and by playing games against each other on a console. Children take turns when playing and follow instructions. Staff use play opportunities well to engage with children. For example, they ask questions and introduce mathematical concepts and new vocabulary. Children learn about the world around them in different ways, including the celebration of festivals.

## Personal development, behaviour and welfare are good

Staff know the children well and interact positively with them. Children are confident to ask for help or to express their views. Children freely talk with adults and visitors. Younger children are self-assured in their interaction with older children. Children comment that they have lots of fun at the club, they can play with their school friends and choose what they play with. The mealtime is well managed and provides a relaxing opportunity for children to talk about and reflect on their day in school. Children's health and well-being are given high priority. They enjoy healthy meals and are encouraged to help themselves to drinks of water to keep themselves hydrated. Children have plenty of opportunity to use the school playground to be energetic. They are enthusiastic as they take part in team games, such as football. Staff are vigilant about the whereabouts of children. They deploy themselves appropriately to ensure children's well-being. Children learn to follow club rules and play safely.
