## Summary of key findings for parents

### The provision meets requirements

- The childminder has a clear understanding of how to safeguard children and how to support their understanding of keeping themselves safe.
- The childminder demonstrates her understanding of gaining ongoing support and networking to continually improve and develop her service. She is keen to reflect on how effective her service is and make changes according to parents' and children's views.
- The childminder clearly understands how to promote healthy lifestyles for children. She demonstrates her knowledge of promoting children's physical well-being through regular exercise, fresh air and healthy food and drink.
- The childminder demonstrates a keen understanding of children's learning and development. She knows how to identify how children learn best and how to help children to progress further in all areas of learning.
- Children's development is able to be assessed appropriately through a programme of initial starting points, observations and tracking to monitor their progress.
- The childminder has clear knowledge of how to promote children's emotional wellbeing. She knows how to install confidence in children of all ages through reassurance and encouragement and how to motivate children to learn through positive teaching strategies.
- The childminder has a clear knowledge of how to work with parents and other settings to provide a consistent approach to children's ongoing development and care.
- The childminder demonstrates a clear understanding of how to provide an inclusive service for all children and their families. She is very aware of developing a service according to children's individual needs to promote their learning and welfare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector looked at documentation that relates to safeguarding and welfare, such as suitability checks for household members.
- The inspector looked at the assessment programme used to monitor children's learning and development.
- The inspector took into consideration the childminder's self-evaluation system.
- The inspector looked at the areas used for childminding, both inside and outside.
